5.0 GENERAL MANAGER'S REPORT – ITEMS ARISING

- two promising applications for two board vacancies
- are a total of five
- to be interviewed by the Mayor and Councillors
- Capital projects all approved
- stage floor and washrooms; theatre closed from mid August to the end of September so will impact rentals
- also new projector and screen
- Markham at the Movies gave \$20,000 to help with the cost
- very generous of them as they are driven by volunteers

- finally getting better traction on digital marketing
- shifting marketing dollars towards digital with good results
- digital is much more cost effective
- get best results from Facebook
- 2016 preliminary financial results look very good
- doing 17-18 programming; need to weigh costs vs. artist availability

- funding is the key consideration
- good framework that has potential
- need to sustain what we do and do it well
- task force can be created at any time
- suggest three Committees –
 - Gala
 - Strategic Plan
 - Sponsorship, Fundraising and Discovery
- had a youth engagement task force; think it's part of Strategic Plan
- bring summary report of what we do for youth through programming, camps, ECEY
- more youth involved than there used to be
- lot of thought put into how to involve students
- section on Facebook for them to give their opinion?

- \$366,233 including gala and sponsors

- results - \$136,000 raised
- hope to learn from last year
- also need more help
- could have done better with the live auction
- need to start now; need bigger items
- new partner – Kate from Kate’s Garden but centrepieces have to be raffled off after
- need to determine venue – three options
 - stay here
 - dinner at Hilton and show here
 - entire event at Hilton (could be a temporary plan)
- 2016 results significantly stronger than any previous year
- need to talk to Patrick, Justin and Alex Chiu re venue
- have given the event a sense of purpose “Discovery”
- do show first then “after party” at the hotel?
- have “pledge performers” pay to perform? might degrade value of the event
- ask customer base of people who actually com which they prefer?
- probably couldn’t do it in time
- very significant change to change locations
- does the artist drive the audience?
