1. CALL TO ORDER

5. BUSINESS ARISING FROM THE MINUTES

Public Art Plan

Committee members have been encouraged to offer suggestions of where art might be placed that makes sense conceptually and aesthetically. Ken Wightman suggested that consideration be given to placing art in the traffic circle on Village Parkway north of Highway 7.

6. WAR MEMORIAL

Corinna Ghaznavi, Public Art Coordinator, reported that the City of Markham obtained a grant from the Canada 150 Community Infrastructure Program, part of the Government of Canada's celebration of the 150th anniversary of Confederation. The grant is being used to revitalize the cenotaph located at the corner of Highway 48 and Highway 7 and to create a gateway to Markham. At its meeting on October 11, 2016, the Markham Public Art Selection Committee selected a proposal submitted by Linda Covit. It is expected that the project would be installed before Remembrance Day 2017.

It was also reported that Markham staff are working with the Veterans Association and the Canada 150 Steering Committee to finalize the project design. Corinna Ghaznavi displayed the original design – two open arches demarcating a circular piazza, with a large round limestone bench in the centre. The artist has been asked to add an additional element: a sculpture representing a flame that would be placed in the centre of the bench. The artist is working on a proposal for the sculpture and also working with a lighting technician to best show off the flame. The words of the poem "In Flanders Fields" will be engraved around the base.

7. CIVIC CENTRE COLLECTION

Chair Steven Lusk suggested that works of Fei Lu, an artist and promoter of art, be considered for the Civic Centre collection. Corinna Ghaznavi reported that in previous years funds had been allocated for the purchase of art pieces by local artists to form the Civic Centre collection; all pieces have been documented and recorded in inventory. Funds have not been allocated this year. To fund the acquisition of local art for the Civic Centre collection, it may be possible to hold an “art in the park” contest, where artists pay to enter the contest.

8. OTHER PUBLIC ART UPDATES

Corinna Ghaznavi reported that Markham plans to introduce plaques that will identify public art pieces. She displayed the proposed design to be used on all plaques. Committee members discussed the design and liked its whimsicality.

9. YORK UNIVERSITY PUBLIC ART SYMPOSIUM

Stephen Lusk advised that there may be an opportunity for the Committee to partner with the City of Markham and York University for the Going Public art symposium on May 18-20, 2017. He noted that this could be an excellent forum for dialogue and panel discussions and to showcase public art programs. Corinna Ghaznavi reported on behalf of Stephen Chait, Director Culture and Economic Development, that Markham would like to be involved. She will discuss possible roles for committee members with symposium organizers.

10. DOWNTOWN MARKHAM PUBLIC ART INSTALLATION

Corinna Ghaznavi reported that Remington Group provided funding for a public art piece to be located on a slip of land near the Remington Group carousel at Birchmount Rd. and Enterprise Blvd. The art installation will be an iconic, prominent artwork announcing downtown Markham. The largest number of submissions in response to the call for proposals was received for this competition. The Markham Public Art Selection Committee has reviewed the submissions and created a short list of five proposals. A site meeting has been held to verify where the art will be placed. March 20, 2017 is the deadline for the shortlisted artists to submit drawings, renderings, proposed timelines and budgets. Going forward, public art contributions from the Remington Group will be negotiated through Section 37.
