Dear Markham Regional Councillors, Commissioner Colins,

In July 2014, Residents on Donald Cousens Parkway (between Country Glen Road and 16 Ave) signed and summited a petition to York Region.

On Sept 16, 2014, Region acknowledged the petition and confirmed that Transportation and Community Planning Department will be undertaking traffic studies in the fall 2014 and will report to council with recommendations in early 2015. However, residents were never informed of any recommendations made to council in 2015.

After countless follow ups, Residents finally had a community meeting with Deputy Mayor Heath and York Region staff on July 15, 2015. It took a year to arrange that meeting. Around 50 residents attended that evening meeting. Traffic volume & noise level data and post-meeting surveys conducted by neighbours were passed onto staff.

The current posted speed limit of DCP is 70km with only two lanes with no emergency parking or road shoulder on the south bound direction. There were situations that EMS and Police service were delayed due to the fact that EMS and YRP officers worried about their own safety on that road. The YRP officer even recommended residents to file a complaint to the city. Stunt driving are also often observed by residents in this area. The posted speed limit 70km was in place when the area was still a vacant land and farm land. It has not changed since 2009 or even earlier. Today, this area on Donald Cousens Parkway is populated with townhomes and detached homes directly fronting DCP with less than 30ft setback. It is reasonable and sensible that the speed limit should lower to accommodate land use. Lowering the speed is the least expensive and most effective way to address safety and noise concern.

After years of promoting Donald Cousens Parkway, it has become a driving behaviour of heavy truckers to use DCP. The removal of the 9<sup>th</sup> Line truck ban hopefully will help to mitigate some problems in the long run; The Region often used the truck volume of 160 per day for its analysis. That data did not reflect the current reality. There are more than 600 heavy trucks using DCP daily at high speed that resulted in excessive noise and vibration.

After 27 months of wait and lack of substantial action, some residents who signed the first petition have sold their homes and left with disappointment. On behalf of the residents of Donald Cousens Parkway (between Country Glen Road and 16 Ave), we are requesting the following actions to be taken immediately:

- 1. Speed limit be lowered from the current 70km to 50 km on Donald Cousens Parkway from 9th line to 16th Ave.
- 2. York Region Police be requested to provide traffic speed enforcement.
- 3. Region staff to study possibility of layby parking on where DCP has no road shoulder and emergency parking.
- 4. All adjacent Regional roads to open for all traffics, no more truck restrictions.
- 5. Region staff to work with the community in a more open and transparent manner with accountability.



### Posted speed limit never changes


April 2009 70km/h

### Indoor Noise Level Data April 9, 2015 6:47am to 6:58am (Duration 11 minutes)








