The Markham Sub-Committee convened at 1:35 pm with Regional Councillor Jim Jones in the Chair.

# 1. Status Update: Mobility Hub and Community Plan Study

Richard Kendall provided a review of the Mobility Hub Study project, the refined study area, the work undertaken to date, the status of the study elements, and next steps.

Discussions involved land development in the area with respect to the provision of transit, and the work plan for the consultants.

Staff recommend that the Mobility Hub and Community Plan Study be put on hold pending completion of the VIVA EA update study to review the transitway alignment through Markham Centre. Amendments to the Hub Study's scope of work and Terms of Reference may be required, based on the transit alignment recommendations that will emerge from the VIVA EA update. It is felt that the VIVA Study will be a more effective process to engage transit agencies on future transit alignments in Markham Centre.

# 2. VIVA

Paul May gave a PowerPoint presentation to explain the proposed Viva projects and improvements to the transit corridors in the Markham area. With respect to the previously planned Markham Centre project, Mr. May outlined realignment factors and issues, the Environmental Assessment amendment process, and the ongoing review of the overall transit network.

Staff responded to questions from the Committee regarding the road network in the Markham Centre area to address traffic congestion. Urban design and public realm elements in Markham Centre were discussed.

## 3. Metrolinx

Brian Lee gave a presentation on service improvements and timelines for Metrolinx initiatives - the Stouffville Line; Regional Express Rail (RER); and the Stouffville Corridor –  $2^{nd}$  track.

- 4) That Planning, Engineering and Urban Design staff be authorized and directed to provide the necessary support to the VIVA study; and,
- 5) That staff report back on the VIVA study and sustainable infrastructure requirements; and,
- 6) That staff report back on the scope of work and appropriate consulting team for completion of the Markham Centre Mobility Hub Study following completion of the Viva EA update by the Region; and further,
- 7) That staff be authorized and directed to do all things necessary to give effect to this resolution.
