## **RECOMMENDATION:**

That the report titled "Heritage Easement Agreements, Abraham Reesor House, 7265 Highway 7, Frank Albert Reesor House, 7323 Highway 7, Lindvest Properties (Cornell) Limited", be received; and,

2) That the Mayor and Clerk be authorized to enter into Heritage Easement Agreements between the City of Markham and the property owner, Lindvest Properties (Cornell) Limited; and,

#### **PURPOSE:**

To authorize the Mayor and Clerk to enter into Heritage Easement Agreements with the property owner for two heritage properties in the Cornell community.

#### **BACKGROUND:**

# The Abraham Reesor House and the Frank Albert Reesor House are significant cultural heritage resources in the Cornell community

The Abraham Reesor House at 7265 Highway 7, a Gothic Revival farmhouse built in 1875, is designated under Part IV of the Ontario Heritage Act (By-law 2007-206). The Frank Albert Reesor House at 7323 Highway 7, an Edwardian Classical style farmhouse built in 1912, is designated under Part IV of the Ontario Heritage Act (By-law 2007-103). Both of these buildings are significant cultural heritage resources in the Cornell community, and are identified as such in the Cornell Secondary Plan.

Heritage Easements are a standard heritage condition of Draft Plan Approval
The protection of significant heritage resources through Heritage Easement agreements is
a standard condition of draft approval. Heritage Easements provide an extra level of
protection for heritage buildings in the context of land development.

# The property owner has agreed to enter into Heritage Easement Agreements with the City of Markham

Lindvest Properties (Cornell) Limited, working with City staff, has agreed to enter into Heritage Conservation Easements with the City of Markham for both of the heritage properties prior to finalization of their draft plan approval process for Cornell Phases 3 and 4.

#### **OPTIONS/ DISCUSSION:**

Council approval is required to authorize the Mayor and Clerk to enter into the Heritage Easement Agreements with the property owner.




Figure 2: Abraham Reesor House, 7265 Highway 7, Cornell Community
