SUBJECT: Main Street Markham North, Highway 7 to Station Street, Parking By-Law Amendment

RECOMMENDATION:

- 1) THAT the report entitled "Main Street Markham North, Highway 7 to Station Street, Parking By-Law Amendment" be received;
- 2) AND THAT Schedule 'C' of Parking by-law 2005-188, be amended by rescinding any existing parking restrictions on Main Street Markham North, between Highway 7 and Station Street;
- 3) AND THAT Schedule 'C' of Parking by-law 2005-188, be amended by prohibiting parking at specified locations on Main Street Markham North, between Highway 7 and Station Street;
- 4) AND THAT Schedule 'D' of Parking by-law 2005-188, be amended by rescinding any existing parking restrictions on Main Street Markham North, between Highway 7 and Station Street;
- 5) AND THAT Schedule 'D' of Parking by-law 2005-188, be amended by restricting parking at specified locations on Main Street Markham North, between Highway 7 and Bullock Drive;
- 6) AND THAT staff monitor the parking demands with the BIA and report back if any further parking restrictions are required;
- 7) AND THAT staff be authorized and directed to do all things necessary to give effect to this resolution.

PURPOSE:

The purpose of this report is to obtain Council Approval to amend Schedule 'C' and 'D' of By-Law 2005-188 to accommodate the new parking layout of Main Street Markham, from Highway 7 to Bullock Drive.

BACKGROUND:

The revitalization of Main Street Markham North, between Highway 7 and Bullock Drive is being completed, which includes dedicated parking bays and wider pedestrian sidewalks. The intent of these revisions is to amend Parking by-law 2005-188 to the revised parking layout. The area is identified in Attachment 'C'.

DISCUSSION:

On-street parking on Main Street previously utilized the existing curb lane and was defined by pavement markings. The recent revitalization of Main Street Markham has rendered Schedule 'C' of the existing parking by-law for Main Street Markham, between Highway 7 and Station Street obsolete. The proposed parking restrictions would apply to areas where parking cannot be physically accommodated or conflict with the Highway Traffic Act (parking in a travelled lane,

within an intersection, or obstructing sightline visibility). Effectively, parking will only be permitted in parking bays.

An extensive consultation process was undertaken during the Environmental Assessment (EA) and detailed design stage with the residential and business property owners along Main Street Markham North to arrive at the current layout.

During the EA and detailed design stage on-street parking was reduced from approximately 84 spots to 62 spots (4 of which are designated as accessible parking spots and 2 are designated as drop-off and pickup locations with a 10-minute time limit). Schedule 'D' of the parking by-law needs to be amended to include the 10-minute parking time limit at the 2 locations shown on Attachment 'D'. A time restriction was requested by the property owners of Turquoise Wholistic, to allow for pickup of groceries, and Dr. Boehnke, to allow patients to be dropped and picked up in front of the building. Dr. Boehnke has parking behind his practice, but due the nature of the injuries to his patients, minimizing the walking distance is important.

As on-street parking is at a premium, businesses need to ensure that employees do not utilize the on-street parking spots. These spots should be for customers only. With assistance from the BIA, Staff will monitor the parking demands on Main Street and report back to Council if time restrictions should be implemented throughout.

FINANCIAL CONSIDERATIONS AND TEMPLATE:

Funds for the signage and pavement markings have been included under Contract 081-T-13 – Reconstruction of Main Street Markham, from Highway 7 to Bullock Drive.


ALIGNMENT WITH STRATEGIC PRIORITIES:

This report aligns with the community safety component of the transportation/transit strategic priority.


