The Senior Heritage Planner explained that four heritage properties are being proposed to be demolished to facilitate site preparation for the new Langstaff Gateway plan. Discussions included the challenges of preserving the buildings on site, due to grading changes and the high-density, transit-oriented nature of the development which is not conducive to the integration of the heritage buildings. Staff gave a presentation, providing details and photos of the buildings.

Staff outlined the options and advised of the applicant's proposals for each of the houses, and staff's recommendations.

The Committee discussed opportunities to retain the buildings on site, in light of the high density development in the area and the value of the land. The process and timelines for the demolition permits were outlined. A suggestion was made that the applicant delay the process and meet with Mayor Scarpitti to try to work out a solution.

Al Duffy, representing the owner, was in attendance and responded to questions regarding the technical challenges; the possibility of retaining the church or a component thereof; a commitment to preserve and restore the Munshaw House; and retaining the houses in a cluster in the woodlot (eastern section of the community). Mr. Duffy advised that the applicant has met with the Mayor on this matter already and agreed to pursue options to preserve the Munshaw House.

HERITAGE MARKHAM RECOMMENDS:

That subject to the applicant entering into a binding agreement with the City of Markham to preserve and restore the Munshaw House at 10 Ruggles Avenue within the Langstaff Gateway community, in a location acceptable to the City and the owner, and withdrawing the objection to the heritage designation; and,

That the applicant agrees in the same agreement to provide one or more plaques commemorating the early 20th century history of the Langstaff community to be placed in a location in the Langstaff Gateway community acceptable to the City and the owner; and further,

That Heritage Markham does not oppose the current demolition permit applications for 75 and 77 Langstaff Road, and 20 and 24 Ruggles Avenue.

The Heritage Planner advised that the building is currently used as a garden centre and the owners wish to develop the surrounding property with 34 semi-detached dwellings and to restore the existing heritage house as a single detached dwelling.

The Committee discussed the appropriate amount of land for the heritage dwelling, including the need for amenity area and potential garage, and suggested reducing the height of the adjacent semi-detached building.

HERITAGE MARKHAM RECOMMENDS:

That Heritage Markham supports the proposed location and orientation of the existing heritage house at 9721 Kennedy Road shown in the proposed by-law amendment application; and,

That Heritage Markham has no objection to the demolition of the modern frame rear addition to the heritage dwelling only; and,

That the applicant either provide a larger lot for the heritage house in order to provide a larger amenity space and opportunity to construct an addition to the house and garage that will not negatively impact the heritage house and make it a more viable and desirable dwelling; or that the applicant architecturally link the heritage house to the semi-detached unit immediately to the east to achieve a more viable and desirable single living unit; and,

That the height of the attached semi be reduced to two storeys to transition to the heritage dwelling;

That the applicant provide a restoration plan for the heritage house which provides for the replication of the original bell-cast roof veranda; and,

That the applicant enter into a Heritage Conservation Easement Agreement and install a "Markham Remembered" plaque as a condition of site plan approval; and further,

That approval be delegated to Heritage Section Staff for further review and comment.
