## 4. 2013 CPAC BUDGET / BUSINESS PLAN

The Committee reviewed the "preliminary thoughts on 2013 CPAC Business Plan - Long List" prepared by Peter Miasek, Elisabeth Tan and Joe Cimer.

The Committee and staff reviewed the proposed 2013 CPAC Business Plan prepared by Peter, Elisabeth and Joe and made suggested amendments.

The Committee suggested that future CPAC agendas should be based on the Business Plan to ensure action items are dealt with in a timely manner.

## 5. MARKHAM'S DRAFT OFFICIAL PLAN - DATES FOR PUBLIC INPUT

Staff advised that the City of Markham Draft Official Plan is available for public review. Staff also advised that the next Public Session relative to the Draft Official Plan is scheduled for April 2013. It was noted that the cycling policies included in the plan are very robust.

## 6. YORK REGION PUBLIC HEALTH REPRESENTATION

The Chair introduced Pan Lalani, Public Health Nurse, Healthy Lifestyles Division Community & Health Services Department who will be replacing Jennifer Wong who is transferring to the Injury and Substance Misuse Prevention (ISMP) Program.

## 7. MARKHAM CYCLING MAP DISTRIBUTION & FINAL COST

Staff distributed a copy of the cycling map to all the members.

The Committee suggested that the map be available at the following locations:

#### 8. UPDATE ON BOB HUNTER TRAIL:

#### a) SITE VISIT

Rachael Woodroffe provided the Committee with a brief summary of the site visit of "area 3". It was noted that there are some issues that still need to be resolved.

#### b) CONSTRUCTION FOR 2013 AND NEXT SITE VISIT

Staff provided an update on the anticipated construction completion areas. It was noted that Phase 1 "Areas 1, 2 and 3" are anticipated to be completed by the end of summer 2013.

## 9. SMART COMMUTE - RESULTS OF SURVEY STATS

The Committee was provided the results of the survey conducted by Smart Commute. They are as follows:

There were 24 Markham businesses whose employees have conducted our Smart Commute commuter survey, based on those survey responses, the % of employee who cycle to work is 0.65%.

#### 10. MARKHAM CENTRE CROSS-SECTIONS AND FUTURE DEVELOPMENTS

Staff advised that the Markham Centre Secondary Plan is being updated and that the Mobility Hub Study needs to be completed. As a result, the Markham Centre Cross-Sections are being deferred.

Councillor Don Hamilton stated concerns that the Secondary Plan will not include dedicated bicycle lanes.
