Dear Deputy Mayor and Councillors,

On behalf of the residents who live on the south side of Steeles and Laureleaf, we are writing this letter to strongly object the zoning amendment application at 378 Steeles Avenue East. Many of the residents do not read English or they are new immigrants and only learned of the rezoning application by word-of-mouth from their neighbours. We had the opportunity to attend the recent two town hall meetings in Markham City Hall rezoning amendment application -378 Steeles Avenue East.

The issue of traffic congestion is a problem. We do not need more traffic nor parking problem nor noises from the new temple at 378 Steeles Avenue. With the new LCBO, the new kung fu school, Shopper's Drug Mart, Royal Bank, Second Cup and the gas station in the plaza in the south east side of Steeles and Laureleaf, plus the

school south of the plaza; we certainly have enough traffic issues already. Laureleaf Road is the only signalized intersection to access Steeles for over 500 homes in our Willowdale neighborhood. A lot of nearby residents and customers from the plaza rely on the traffic light at Steeles and Laureleaf to make left turns. The intersection at Steeles and Laureleaf is already busy enough.

Fung Loy Kok, the new temple will certainly increase the traffic congestion on Steeles Avenue. According to 2005-2006 City of Toronto 24 Hour Traffic Count, just over 40,000 vehicles pass 378 Steeles Avenue East on a daily basis. Traffic congestion has grown worse since the traffic count was taken five to six years ago. We personally are experiencing the pain of traffic congestion on Steeles Avenue on the way from home to work and on the way from work to home i.e. twice a day and at least five days per week. We don't want to suffer more pain from the potential increase of traffic from the new temple.

Fung Loy Kok offers regular tai chi classes i.e. 6 to 7 days per week between the hours 9am to 9:30pm (more than 12 hours a day). This will certainly added to the existing traffic congestion six to seven days a week and throughout the day. This type of daily operation is not suitable for a residential neighbourhood. The lack of parking space in the proposed site will certainly create serious parking problem on Laureleaf Road and the nearby roads. As the result the traffic congestion on Laureleaf Road will be getting worse. We have to point out that Laureleaf Road is the only signalized intersection to access Steeles in our neighbourhood.

Moreover, as far as we know, all of Fung Loy Kok's eleven Greater Toronto Area sites are located in commercial and industrial areas, not residential neighbourhoods like 378 Steeles Avenue East.

Again, we strongly object to the zoning amendment application - 378 Steeles Avenue East. Certainly, we, the residents in North York need your strong support to object the zoning amendment application.

'A residential site should remain a residential site.'

The applicant is proposing to demolish the existing residential home and build a new flat-roof building. The proposed eight—metre high building will be elevated above ground level by supports and cantilevered in order to provide, beneath the structure, ground-level parking spaces for up to 30 cars. An open-air elevated terrace will be located on the east side. The Bayview Glen Residents Association recently received a copy of a new traffic-parking assessment study submitted by Poulos & Chung in support of the Fung Loy Kok Institute of Taoism's place of worship rezoning request for 378 Steeles Avenue, East.

On behalf of the Association we would like to take this opportunity to make comment and to bring to the Town's attention significant issues that we believe have not been addressed in the current Poulos & Chung Traffic-Parking Assessment Study.

The study is based on assumptions without substantiating data or documentation, ignores operational and safety issues such as potential traffic conflicts, turning volumes generated by through movements (number of movements), question of sufficient spacing between multiple at-grade intersections, volume/capacity ratios at critical signalized intersections (Laureleaf/Steeles) and traffic volumes.

Major shortfalls of the Poulos & Chung Study are:

- The recommendation is incorrectly predicated on one service per day offered four to five days per week. The study ignores Fung Loy Kok's current operating GTA sites, sites that provide three to four daily services over a 12+ hour schedule (9:00am 9:30pm), operating six to seven days per week. (A list of current GTA Fung Loy Kok site locations with hours of operation has been provided as an attachment)
- The study fails to note that all current Fung Loy Kok GTA sites are located in commercial and industrial zoned areas (see attachment, pages 5-6), not residential areas such as 378 Steeles Avenue, East. Commercial and industrial areas are designed to accommodate the traffic generated by the applicant's daily multiple service schedule.
- The traffic- parking study in support of the application does not promote or support a land use policy that is consistent with safe operational management access of the site or addresses the operational capacity challenges of Steeles Avenue, East and surrounding residential streets.

The Fung Loy Kok (FLK) project is recommended in a neighborhood already dealing with an ongoing problem of over flow parking created by a concentration of three places of worship on Bayview Avenue.

The Town of Markham has not been able to successfully resolve the problem despite introducing restricted parking on several of the neighborhood side streets. The Bayview Glen Alliance Church, 300 Steeles Avenue, East, is located just 750 meters to the west of the applicant's 378 Steeles Avenue, East, proposed place of worship.

As residents have discovered, restricted parking is not a solution to place of worship over flow parking and is not a substitute for good planning and sustainable rezoning development. The current neighborhood

conditions are ignored with no recognition of the potential over flow parking problem or horizon statement in terms of future membership and attendance figures.

There are a number of issues of concern. Those issues are as follows:

- Number of worship services and frequency of worship services/horizon year impact;
- Maximum parking/traffic demand;
- Traffic Volume on Steeles Avenue, East;
- Volume/Capacity ratio at signalized Laureleaf/Steeles intersection, main westbound Steeles Avenue access for Laureleaf Road (South) and Steeles Avenue commercial plaza traffic;
- Proximity of three at- grade traffic intersections on Steeles Avenue; deflection traffic movements and inbound/outbound movements;
- Adequate intersection(s) motorist stopping line of sight distance and setback to 378 Steeles place of worship;
- A left turn into 378 Steeles from eastbound Steeles is unsafe and possibly illegal;
- A left turn out of 378 Steeles onto eastbound Steeles Avenue is unsafe and possibly illegal;

Number of worship services, frequency of services and horizon years: Poulos & Chung statement (page 2), "On average one service is held per day and occurs approximately four to five days per week." This statement is a gross underestimate of the potential scheduled services to be offered at the 378 Steeles site and is not consistent with Fung Loy Kok's current unique worship service patterns that are offered to the general public in commercial and industrial zoned locations across the GTA (i.e. Scarborough, Bathurst Street, Kingston Road, Mississauga and Richmond Hill).

A key factor in determining the traffic impact in terms of operational and safety issues is the frequency in which the services are offered. The service schedule, as currently offered at GTA locations, is available, on average, three to four times per day and scheduled between 9:00 am to 9:30 pm - a 12+ hour schedule of services operating six to seven days per week

There is no horizon statement of impact of increased frequency of services and what the effect will be on the traffic movements and surrounding residential neighborhood with a history of place of worship over flow parking problem, despite the fact that FLK practices an ambitious membership campaign promoted in local print and broadcast media.

<u>Maximum Parking/Traffic Demand</u>: Based on the 378 Steeles site's parking spaces of 30 spots, the site is capable of generating up to 90 cars per day based on current worship patterns (3 services x 30 cars), requiring 180 inbound/outbound movements — traffic movements which will undoubtedly have a negative impact on Steeles Avenue traffic and the Willowdale-Thornhill residential neighborhoods.

The figure of 180 inbound/outbound movements is a conservative estimate and does not account for future growth potential or service demand as is evident by the current Scarborough and Bathurst operations.

<u>Traffic Volumes on Steeles Avenue, East</u>: Poulos & Chung statement (page 1), "Steeles Avenue is designated as an arterial road and is designed to accommodate high volumes of traffic flow at urban posted speed limits." This is a statement reflecting ideal conditions; ideal conditions do not exist on Steeles Avenue East, particularly between Leslie Street and Bayview Avenue.

City of Toronto's most recent (2005) Steeles Avenue, East (Leslie Street to Bayview Avenue) 24 hour average traffic count reported vehicle measurement of 21,259 (north side) and 20,567 (south side).

Steeles Avenue, East, traffic (fronting the 378 Steeles site) exceeds levels found on corresponding east west roadways, such as Cummer, Finch Avenue, Sheppard Avenue, East, and York Mills Road. Traffic volumes on Steeles Avenue, East, are equivalent to volumes experienced in downtown Toronto. The latest York Region/City of Toronto Steeles Avenue Traffic Count Cordon (2006) measured, in a 12 hour period (7:00am – 7:00pm), 1, 012,240 vehicles.

<u>Volume/Capacity ratio of signalized Laureleaf/Steeles Intersection, Laureleaf (South) access</u>: The volume to capacity ratio of traffic at the signalized intersection of Laureleaf and Steeles is ignored in the Poulos & Chung study. Thornhill's Laureleaf Road experiences high level of transient through traffic and is a popular shortcut for motorists wishing to avoid the Bayview and Steeles intersection.

Ignored in the study is the impact on the Willowdale residential neighborhood of 600+ homes; Steeles Avenue is the only major arterial road in and out of the neighborhood. Willowdale's Laureleaf Road is a collector road and the only signalized Steeles Avenue inbound/outbound point for Laureleaf South and surrounding streets. Laureleaf Road South also provides access for much of the traffic exiting/entering the Steeles (commercial) Plaza and Esso Station located on the southeast corner of Laureleaf Road and Steeles Avenue East.

Residents on both sides of Steeles Avenue must often sit through multiple green light cycles before being able to access westbound, Steeles Avenue, which fronts the applicant's 378 Steeles place of worship. What impact, safety and operational, would inbound/outbound traffic for Fung Loy Kok's 378 Steeles worship services contribute to the Laureleaf Road/Steeles Avenue volume/capacity ratio levels?

<u>Proximity of three (3) traffic at-grade intersections/ deflection traffic movements, north side of Steeles raises operational and safety issues:</u> There are three at -grade traffic intersections within a 200 meter stretch of Steeles Avenue East (Laureleaf Road (N) to Valloncliffe Road) in which the applicant's property is located.

The three traffic intersections are, Laureleaf/Steeles (signalized) four (4) legged intersection, Olive Villa Way/Steeles (new residential subdivision) three (3) legged intersection, and Valloncliffe Road/ Steeles, three (3) legged traffic intersection. All three intersections have an exclusive left turn lane for eastbound traffic exiting Steeles Avenue.

The applicant's property is located between the Laureleaf and Olive Villa Way intersections and approximately 61 meters to the west of the Laureleaf Road intersection (Poulos & Chung Study, page 1, states the distance is 75 m. We believe this figure should be confirmed).

There is no reference to westbound through Steeles Avenue (60 km/h) traffic that must anticipate and react to 378 Steeles outbound/inbound vehicles crossing multiple lanes of westbound Steeles Avenue in order to exit or enter the property. A vehicle travelling at 60 km/h in dry conditions takes approximately 50 m. (@ 164 feet) to come to a complete stop.

Also ignored is the right turn Laureleaf Road traffic accelerating to enter westbound Steeles Avenue traffic stream which would be required to anticipate and react to 378 Steeles east/west, inbound/outbound traffic located a distance of 61 m. from the intersection.

The 378 Steeles Avenue, E., outbound/inbound traffic movements must either cross multiple Steeles Avenue traffic lanes, negotiate eastbound Steeles Avenue Laureleaf Road exclusive left turn lane queuing traffic in addition to anticipating and reacting to oncoming left turn westbound traffic exiting onto Steeles Avenue from Laureleaf South and the Steeles commercial plaza.

What impact will inbound/outbound traffic generated by the daily Fung Loy Kok services have on intersection operational and safety issue guidelines?

Adequate intersection(s) stopping line of Sight: Adequate intersection stopping sight distance and setback has not been addressed in the Poulos and Lee Study. Motorist's line of sight stopping distance in terms of 378 Steeles inbound/outbound traffic should raise question of safety and best practices guidelines. Multiple streams of traffic generated from a concentration of three traffic intersections increases risk of collision with inclusion of inbound/outbound 378 Steeles place of worship traffic flows.

<u>Left turn into 378 Steeles from eastbound Steeles Avenue</u>: Poulos & Chung study (page3) states, "Eastbound left turns into the site are facilitated by the storage and taper length available from the exclusive eastbound left turn lane at Laureleaf Road." The Steeles Avenue eastbound exclusive Laureleaf Road left turn lane would require all queuing traffic to exit onto Laureleaf Road, not 378 Steeles as suggested by the Poulos & Chung study.

Vehicles accessing 378 Steeles from the exclusive Laureleaf Road left turn lane would create collision risk for those Laureleaf (North) Road vehicles making right turns onto westbound Steeles Avenue. A left turn into 378 Steeles from the eastbound exclusive Laureleaf left turn lane would be unsafe and possibly illegal.

Left turn exit from 378 Steeles onto eastbound Steeles Avenue: The Poulos & Chung Study states (page 4), "The existing traffic signal at Laureleaf Road provides with its available signal timing sufficient gaps to assist left turns into and out of the site." Statement cannot be substantiated without Laureleaf/Steeles intersection study to determine volume and capacity at signalized intersection. Exiting eastbound Steeles Avenue, left turn traffic from the 378 Steeles site would be at risk of collision with vehicles queuing in the exclusive Laureleaf left turn lane.

Vehicles exiting eastbound onto Steeles Avenue from the site must cross two westbound Steeles Avenue traffic lanes, an exclusive eastbound Laureleaf left turn lane before able to merge with eastbound Steeles Avenue traffic flow. This traffic maneuver would increase risk of collision and possibly is an illegal turn.

The issue of pedestrian safety is also not addressed. The proximity of multiple traffic intersections and inbound/outbound traffic generated by the applicant's multiple daily services should raise the question of risk to pedestrian safety.

Approval of the Fung Loy Kok rezoning request will set a precedent for incompatible and unsustainable rezoning and development along the residential corridor of Steeles Avenue, East.
