# 4. Main St. Unionville Development

Harshal Dave presented his development proposal inside his board room office at 157 Main St. Unionville. Harshal introduced himself and his company the Watford Group a Real Estate Development, Insurance and Private Equity firm. The Watford Group has entered the Canadian market within the last four years and has held an office on Main St. Unionville for over a year and half. Harshal went on to introduce his plans for Main St. Unionville and started by acknowledging the effort of the community stake holders and local businesses that have helped to develop the Main St. Unionville brand. Harshal then segue into the Watford Group's proposal to build a five storey luxury high rise condominium with a roof top amenity space, underground parking and a pedestrian cobblestone piazza connecting the development to Main St. Unionville. The development will be behind the west side of Main St. by the rear parking lot of 162 to 194 Main St. Unionville. When completed the development will have an anchor store that will help to drive business to small retail stores. Permits for the Watford Group's development are being submitted to the City of Markham over the next few weeks and shovels will be in the ground no later than a year from then. The entire project will take approximately three years in total. Tony has invited Harshal to meet with key members on the Visioning Committee to further discuss the Main St. Unionville development.

#### 5. Clever Samurai

Jana and Leigh-Ann of the Clever Samurai both introduced themselves and presented their marketing proposal for 2018. The group then presented the three priorities they were asked to focus on; air cover from March to pre-summer to the end of May/June, a marketing plan during the holiday season and develop a plan to get all businesses (mainly retailers) along Main St. Unionville to act in a cohesive manner. Jana and Leigh-Ann then explained the details of the marketing proposal. The Clever Samurai's marketing proposal will be postponed until the website redesign is completed.

#### 6. Sponsorships

Plans for the 49<sup>th</sup> Unionville Festival are underway for the 2<sup>nd</sup> and 3<sup>rd</sup> of June. The Festival Committee is planning for the next two years building up to the 50<sup>th</sup> festival. Reid thanks the UBIA for it's generous donations in the past and is proposing a two year sponsorship commitment. \$8,000 for this year and \$10,000 for the 50<sup>th</sup> year to help cover increased expenses such as increased security costs and fees paid to the fireworks company last year because construction was not completed in time for the Festival due to bad weather. Tony – would the Festival committee be open to making the Festival a week long event minus Friday nights which are usually problematic, if we can make this a week long event where the UBIA can then get more foot traffic then the UBIA board can justify the increased donation cost. Reid - may be after the 50<sup>th</sup> Festival the City of Markham may have to organize the event. Tony- may be the UBIA could organize the Festival.

Reid also goes on to mention most retailers chose not to participate in the Festival – it would be beneficial for them to participate.

**Markham Jazz Festival** – requesting \$4,500 in sponsorship an increase of \$500 this year to cover the increased expenses.

**Thursday Nights at the Bandstand** – Bill Dawson is asking for a \$3,500 sponsorship this year and asking the UBIA to pay for portable washrooms along side the Bandstand.
