#### 1. CALL TO ORDER

The Environmental Advisory Committee convened at 7:12 pm with Karl Lyew in the Chair without quorum. Quorum was obtained at 8:08 pm. The Chair welcomed the new members to the Committee and announced that Aamir (Mohammed) Sadiq has resigned.

#### A) Information reports on Markham Initiatives and Council Matters

Deputy Mayor Jack Heath indicated there will not be a Deputy Mayor Walk for the Rouge this year as it is an election year. Also, it was announced that there will not be a Rouge Day Brochure produced.

A final review of the environmental aspect of waste management in Markham is underway. Deputy Mayor Jack Heath commented that yard waste is the biggest thing and further that the shipment of newsprint to China is being terminated.

Deputy Mayor Heath indicated that MEAC may need to meet over the summer to help work out questions for the Rouge Park Committee's meeting with Parks Canada. The Zoo and Environmental Group will also attend that meeting.

## A) Review of Planning & Undertaking of Earth Day Event

Jennifer Wong extended thanks to the Committee for the tremendous success of the recent Markham 2018 Earth Day Event.

## 2019 Earth Day Planning Suggestions

- The tally from the passports has not yet been completed, but appears there were fewer participants than last year
- Run sheet is complete
- Start planning event sooner book the venue and strike a planning sub-committee earlier
- Consider asking exhibitors for nominal registration fees to help offset costs for event
- Communication to participants committee members, exhibitors, volunteers, signage etc needs to be clearer in order to better serve the public
- Need to think about partnerships earlier than November
- Would like new information every year
- Not enough children's programs
- The animal exhibits lost a lot of momentum being outside the area
- Committee should ensure that all members are well informed and able to answer questions throughout the day – explaining event, getting feedback, explain the passports, manning booths; be able to explain to attendees what MEAC is and does and possibly recruit new members
- A more visible space for speakers and presenters would allow for better attendance; and schedule presentations more efficiently - they do not need to take up whole day – Mark Cullen presentation was very popular
- Mobile signs were not available and could have better served the event
- Suggestion that maybe the Aaniin Community Centre & Library should be considered as a possible venue for 2019 and the Committee agreed to investigate this further.
  - o Parking may be issue, but could check YRT for shuttling
  - o Some schools or churches could provide additional parking

- Electronic cars a very successful component; Nissan had no cars available; having someone from dealerships at each vehicle to answer questions should be considered; better signage
- Could have done an educational component from the City things like fuel savings

## B) Regional EAC in October 2018 Preliminary Planning

The Chair advised that the Committee will be volunteering to host the 2018 Fall Regional Environmental Advisory Committee Forum. The agenda will be set by York Region and all York Region Environmental Advisory Committees will be invited to attend. The Chair also reminded the Committee of the upcoming Regional Environmental Advisory Committee Spring Forum in Whitchurch-Stouffville on June 12, 2018, and invited MEAC members to consider attending.

## A. Municipal Energy Plan

It was announced that the Municipal Energy Plan is going to Council for final endorsement on May 22<sup>nd</sup> with some stakeholders making deputations. Markham would like to get to net 0 for energy emissions by 2050.
