# 1. ADOPTION OF THE MARCH 6, 2017 MINUTES

The March 6, 2017 Markham Sport Hall of Fame Board meeting minutes were tabled to the next meeting.

# 2. Markham Sport Hall of Fame discussion

### Direction/Mandate of Board

Chair, Meg Stokes, declared that there had been a lack of clarification by the City with respect to the role of the Board in developing the Markham Sport Hall of Fame, and sought clarification

from City Staff and Council members attending the meeting regarding the direction and mandate of the Board.

Bruce Barnett echoed many of the sentiments put forth by other Board members, and explained to Staff and Council members sitting on the Board that Board members are deeply committed volunteers with full-time careers and limited time to carry out the large-scale Hall of Fame project. Members do not have time to waste, and await clear direction from Staff and Council before the Board takes a next step.

Mayor Frank Scarpitti suggested that the Board draft a Memorandum of Understanding to create and solidify working parameters and responsibilities for the Board, allowing the Board, Council and Staff to have a mutual understanding of what the Board will do and how.

Andy Taylor, Chief Administrative Officer was present to field concerns from the Board. He suggested that he meet with members of the Board and review the Project Status Update Presentation given to Development Services Committee on February 27, 2017 to review and prioritize the project's next steps that had been outlined in the presentation. He advised that the CAO's Office would facilitate discussions between the Board and City Staff, so that the project's next steps could be carried out.

The Board expressed their satisfaction with solutions offered by Mayor Scarpitti and Andy Taylor, CAO, and will delegate a subcommittee to meet with the CAO's Office in the coming weeks.

#### Follow-up to Markham Sports Community Following Markham Sport Hall of Fame Breakfast

Meg Stokes reminded members that the Board had committed to follow up with Markham's sports community within two months following the Markham Sport Hall of Fame Breakfast to update them on the progress of the Hall of Fame.

Paul Cicchini advised the Board that he has since spoken with numerous local sports groups who are excited and eagerly awaiting an update from the Board on the progress of the Markham Sport Hall of Fame.

It was suggested that the Board communicate to the Markham sports community that the Board will be meeting with the CAO's Office in the coming weeks to establish next steps in the project.
