RECOMMENDATION:

1) THAT the report, "Canada 150 Community Infrastructure Program (Intake Two) - Grant Application", be received;

- 2) AND THAT the Commissioner of Community and Fire Services be authorized to apply to the Canada 150 Community Infrastructure Program for those infrastructure projects selected by Council;
- 3) AND THAT staff report back on appropriate funding sources should Markham be successful in obtaining one or more grants;
- 4) AND THAT staff be authorized and directed to do all things necessary to give effect to this resolution.

PURPOSE:

The purpose of the report is to seek authorization to apply for grant funding for selected Markham infrastructure projects from Intake Two of the Canada 150 Community Infrastructure Program.

BACKGROUND:

Through the Federal Government's Economic Action Plan 2015 and as a part of a coordinated federal approach to celebrating the 150th anniversary of Confederation in 2017, the Government of Canada has launched the Canada 150 Community Infrastructure Program. Intake One closed in June last year with over 1,100 applications. The funding results for Markham's applications were as follows:

The total amount of grant funding received by the City of Markham from Intake One totalled \$1,083,571. The two approved projects are currently in progress.

Citing the success of Intake One, Intake Two was announced on May 24, 2016. The Government of Canada is doubling its investment in community and cultural infrastructure by providing an additional \$150 million over two years to renovate, expand or improve these spaces across Canada. For southern Ontario, the Federal Economic Development Agency for Southern Ontario (FedDev Ontario) is delivering the program with an allocation of \$44.4 million.

The eligibility requirements of Intakes One and Two are the same.

OPTIONS/ DISCUSSION:

Program Criteria and Eligibility

Canada 150 Community Infrastructure Program provides funding for the rehabilitation, renovation, and expansion of <u>existing</u> community infrastructure assets that are non-commercial in nature. An eligible project must be:

- Open for use to the public and not limited to a private membership;
- Leverage a minimum of 50 percent of funding from other sources with potential priority given to projects that leverage 66.6 percent or more (maximum grant amount per project is \$1.0 million); and
- Be substantially completed by March 31, 2018.

Ineligible projects include construction of <u>new</u> infrastructure, temporary installations, or facility expansions that would result in more than 50 percent increase in square footage.

Eligible projects must fall within the following project categories to be eligible for funding under the program:

- Community centres (including Legion Halls);
- Cultural centres and museums;
- Parks, recreational trails, including fitness trails, bike paths and other types of trails;
- Libraries;
- Recreational facilities including local arenas, gymnasia, swimming pools, sports fields, tennis, basketball, volleyball or other sport-specific courts, golf courses, ski hills or other types of recreational facilities;
- Tourism facilities;
- Docks;
- Cenotaphs; and
- Other existing community infrastructure assets for public benefit that have a local community impact, such as local roads, drinking water treatment and distribution systems, connectivity and broadband, local airports, solid waste management and wastewater infrastructure.

The deadline to apply for Intake Two funding is 5:00 p.m. EDT on June 24, 2016.

Markham's Approach Relating to Canada 150 Infrastructure Program

The Executive Leadership Team (ELT), at its June 1st meeting, used the following considerations to arrive a list of potential Markham projects to include in this report for Council's consideration:

- 100% compliance to the Canada 150 Program requirements, including a maximum program grant of \$1,000,000 and a minimum of 50 percent funding from other sources;
- Alignment to City of Markham priorities;
- Priority given to projects that provide high visibility and generate community excitement due to the celebration nature of this funding;
- Capital projects that have a community infrastructure focus;
- Capital projects that have little to no additional operating costs and extend the life cycle of existing assets; and
- Projects that can be substantially complete by March 31, 2018.

Staff is seeking Council decision in identifying the projects to be submitted to Intake Two of the Canada 150 Community Infrastructure Program. For reference, three projects were selected by Council for application as part of Intake One last year.

Note: * For Projects F & G, staff has identified a potential risk in meeting the funder's timeline in light of the requirements relating to project plan development and community input/engagement.

FINANCIAL CONSIDERATIONS AND TEMPLATE:

City of Markham will provide a minimum of 50 percent of funding for qualified projects submitted to FedDev Ontario. Any grant funding received through the Canada 150 Community Infrastructure Program will reduce the requirement for municipal funding sources for previously identified capital project priorities. Staff will need to identify a funding source should Markham be successful in obtaining one or more of the grants. There will be operating and lifecycle impacts for any of the projects that are approved.
