4. Business Arising From the Minutes	<p>The Committee reviewed the action items from the previous meeting.</p>	
5. Canada's First Monarch Butterfly Friendly City	<p>Jessica Yau, Sustainability Assistant was in attendance to report that Council proclaimed Markham as Canada's first Monarch Butterfly Friendly City. The City is taking this action as the monarch butterfly population has been declining steadily over the years. The butterfly like other pollinators helps move pollen from one plant to another, which helps flowers blossom and our fruit and vegetables grow. The Sustainability Office will be implementing the following actions to help create a monarch friendly environment:</p> <ul style="list-style-type: none"> • Launch a public communication effort to encourage citizens to plant monarch gardens at their homes or in their neighbourhoods; • Communicate with community gardens groups and urge them to plant native milkweeds and nectar producing plants; • Convene a meeting with gardening leaders in the community to discuss partnerships to support monarch butterfly conservation; • Continue to support the monarch & pollinator friendly demonstration garden at City Hall; • Consider the use of native milkweed and nectar plants on city properties where appropriate. • Identifying opportunities for milkweed/ nectar plants, planting & seeding programs; 	<p>Look into if milkweed is poisonous to cats, dogs, and children – Jessica Yau</p> <p>The Committee noted that the milkweed may be poisonous to cats, dogs, and children and requested that staff look into this. Staff suggested that only certain types of milkweed are poisonous and that it is only poisonous if large quantities are consumed, but agreed to do further investigation on the matter.</p>

6. Barn Cat Program	<p>An OSPCA officer was in attendance to provide an overview of Markham's barn cat program. Most of the cats are brought to horse farms. The cats are kept in confinement for one to two weeks. The confinement period is to ensure the cat are aware that the farm is where they will receive food and shelter. The barn owner is responsible for feeding the cats and for providing them with any necessary medical attention. The OSPCA will check in on the cats from time to time. The barns have been found through previously established relationships with barn owners.</p> <p>The Committee noted the importance of checking in on the cats to ensure they are settling in well, and being treated well. It was also suggested that the confinement period be extended to ensure that the cats learn that the barn is where they get food and shelter as per the recommendation of almost every feral and stray cat group, experts suggest 3-4 week minimum.</p>
