1. Minutes of Markham Live Committee – April 18, 2011

2. Sponsorship Assessment/Revenue Analysis Lang Marketing Network

David Matys of Lang Marketing Network gave a presentation of the Sponsorship Assessment and Revenue Analysis. For the purpose of marketing, the Consultants have assumed everything in the building is for sale, and assumed that MISTA is a stand-alone property. A range of potential revenues was provided. Mr. Matys outlined the approach to valuing sponsorship potential and key considerations and challenges.

A recommended sponsorship structure was presented. Sponsorships could be monetary or in-kind. The analysis summary estimates a 20-year term total revenue of \$28,800,000. Comparisons were made to similar venues across Canada, using annual attendance, highway exposure and market size as some of the comparables.

MISTA's biggest strengths are its projected traffic/attendance numbers, the diversity of its appeal across multiple sports and entertainment audiences, and its high visibility on the 407 corridor, as well as the cultural diversity of the area that is attractive to corporate sponsors that seek the significant growth market of the immigrant/ethnic population. The positioning of MISTA as an elite "International" Amateur Sport Training Centre significantly enhances its brand value and appeal. MISTA's weaknesses involve the areas of market reach, television broadcast exposure and national media coverage, and Markham's smaller population compared to centres such as the City of Calgary.

The Committee questioned if capital costs (i.e. signage) are borne by the Town or the sponsor.
