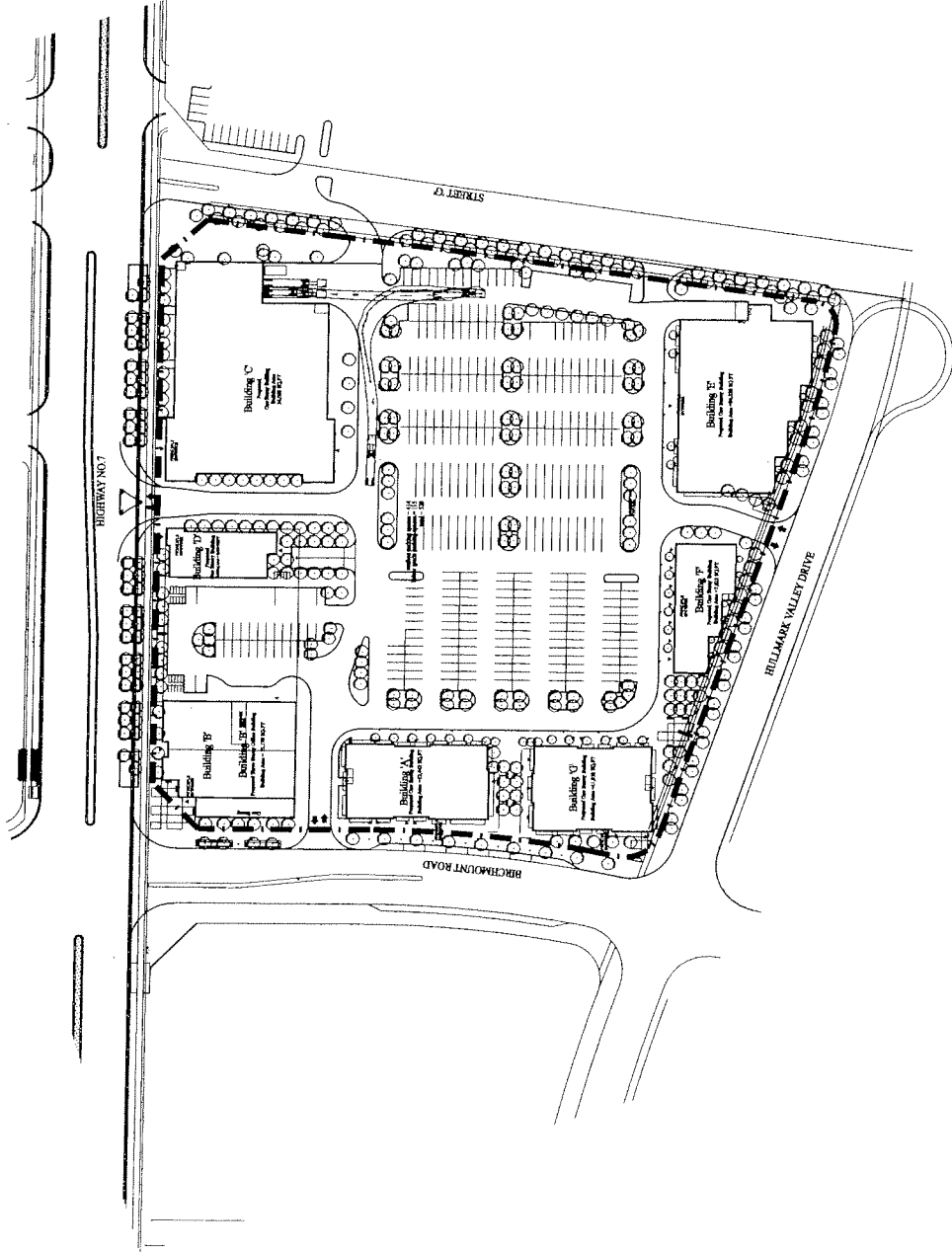

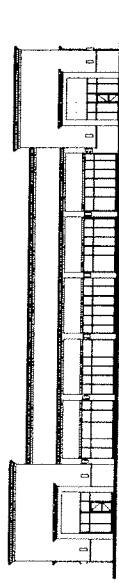

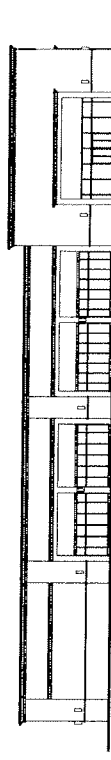
BUILDING C EAST ELEVATION

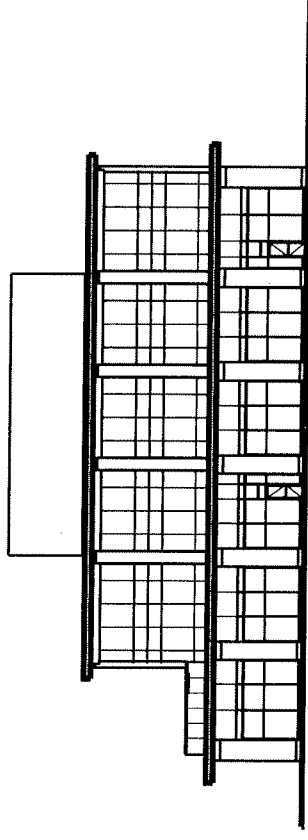
BUILDING B NORTH ELEVATION

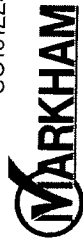


BUILDING B SOUTH ELEVATION

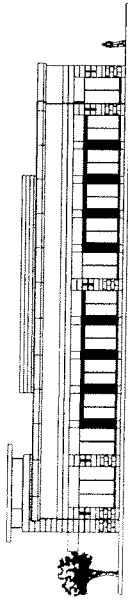

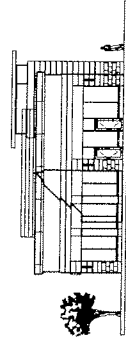

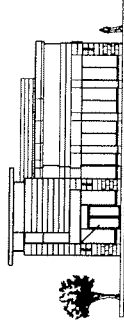
RBC BANK WEST ELEVATION



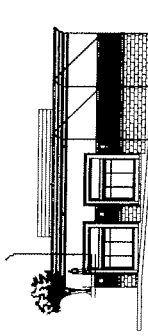
Building D - East Elevation



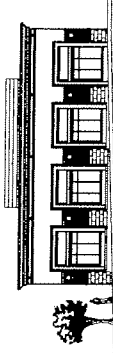

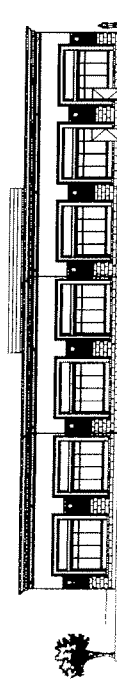

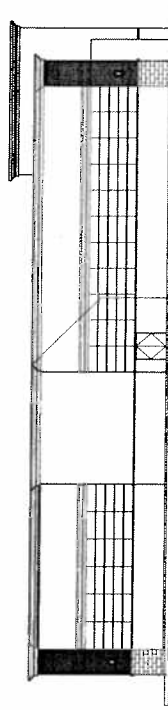
Building E - North Elevation

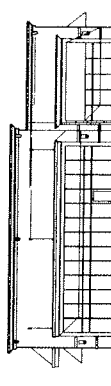
Building A - East Elevation



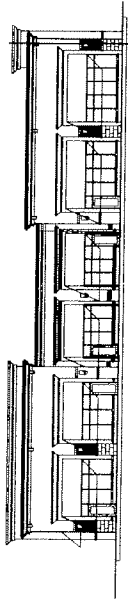
Building A - West Elevation



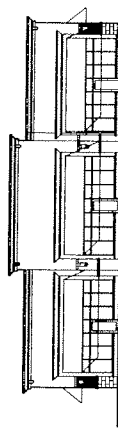
Building A - North Elevation



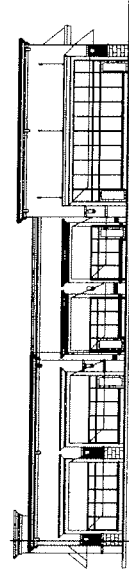

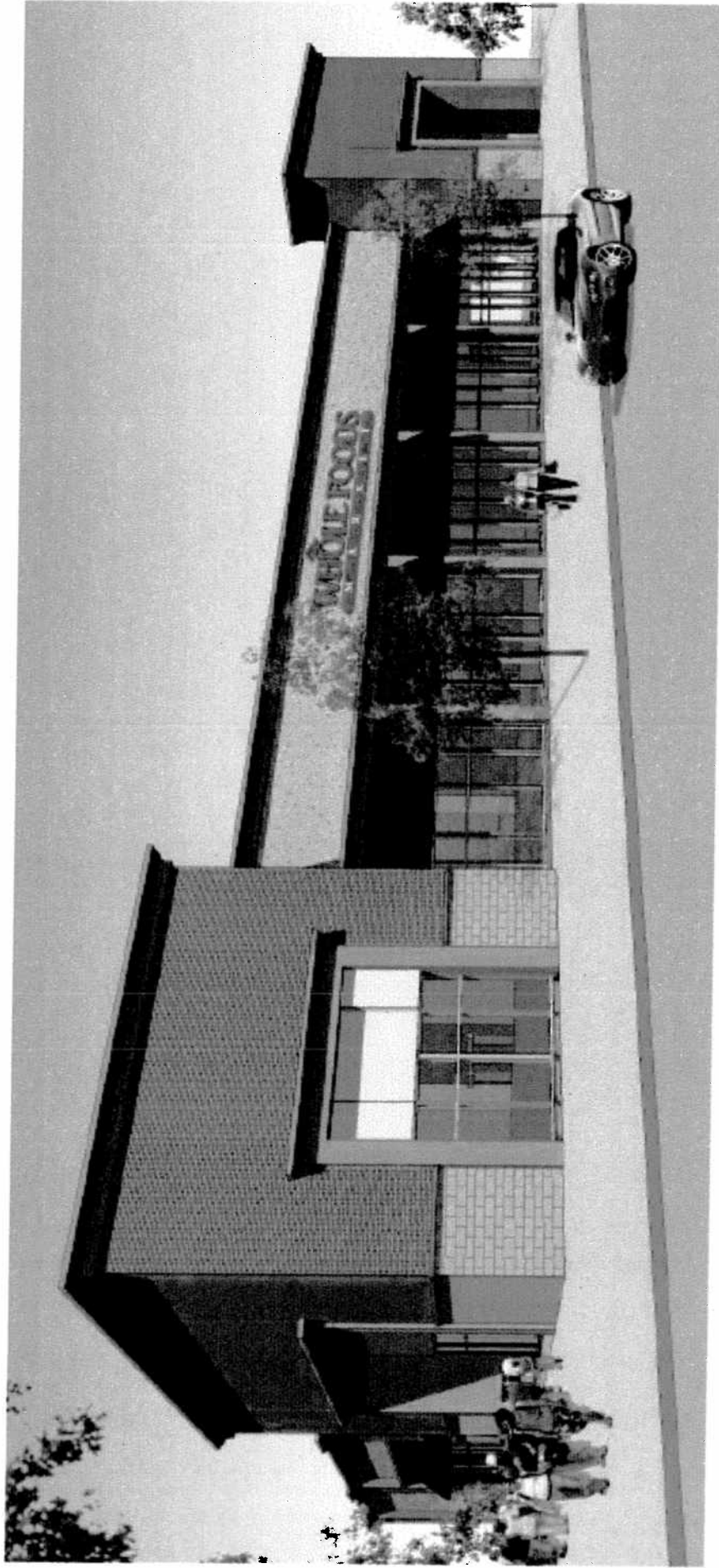
