RECOMMENDATION:

PURPOSE:

To inform Council of Staff Awarded Contracts >\$50,000 for the month of November 2015 as per Purchasing By-law 2004-341.

BACKGROUND:

Council at its meeting of May 26th, 2009 amended By-Law 2004-341, <u>A By-Law Establishing Procurement, Service and Disposal Regulations and Policies.</u> The Purchasing By-Law delegates authority to staff to award contracts without limits if the award meets the following criteria:

- The award is to the lowest priced bidder
- The expenses relating to the goods / services being procured is included in the approved budget (Operating/Capital)
- The award of the contract is within the approved budget
- The award results from the normal tendering process of the City (i.e. open bidding through advertisements that meet transparency and enables open participation)
- The award is to the lowest priced bidder
- The term of the contract is for a maximum of 4 years
- There is no litigation between the successful bidder and the City at the time of award
- There are no bidder protests at the time of contract award

If one (1) of the above noted criteria is not met then any contract award >\$350,000 requires Council approval.

Where the contract being awarded is a Request for Proposal (RFP) the approval authority limits of staff is up to \$350,000.

Note: As per the Pan Am funding agreement, the City of Markham has committed up to \$46.59M to the Pan Am facility. All Post Works are included as part of the overall funding agreement with TO2015.

BACKGROUND

This individual project is part of the Post Works Expenditures Outside of the Construction Contract. Curbs and plantings were not installed and planting areas were temporarily paved over at the request of TO2015 so as to have a flat Games Village area for tents and trailers etc.

The first phase of this work is the removal of the asphalt in-fills and reconstruction of the curbs in the Pan Am parking lot after the Pan Am Games (235-Q-15). The second phase is the construction of the planting beds and the plantings including trees within the reconstructed curbs and resulting islands. All work of this project is contained within the boundaries of the Markham Pan Am Site.

As per the Pan Am Project agreement and budgeted under the Expenditures Outside of the Construction Contract, an amount of \$185,000.00 was budgeted for the construction and restoration of the parking lot curbs and plantings. These costs are shared as per the Facility Agreement and the formula within this agreement.

Schedule: Phase 2 is scheduled to start upon completion of Phase 1 and to be complete by November 25, 2015.

BACKGROUND

Streetlight upgrades are implemented to improve lighting levels in older areas to improve safety. This program is to install new streetlights and/or upgrade existing streetlights based on lighting level analysis. This project includes the supply and installation of 10 new streetlight poles, supply and installation of 8 new streetlight brackets, arms, and luminary on existing PowerStream wooden poles, removal and disposal of existing streetlight poles and streetlight pole straightening.

It is expected that construction will commence in October 2015 and be substantially completed by May 2016.

Staff recommends not awarding the contract to the lowest priced bidder Langley Utilities Contracting Ltd. In accordance with Purchasing By-Law 2004-341, Part II, Section 15 (1) "The City reserves the right, in its sole discretion, and without incurring any liability whatsoever, to accept or reject any or all Bids, or to cancel the Quotation process at any time, without cause, if deemed in the best interests of the City to do so."

The lowest bidder misinterpreted the Bid document and miscalculated their pricing for numerous items within the bid document. City staff are concerned about the inherent risks associated with awarding a contract based on pricing that does not adequately reflect the contractor's costs. Furthermore, the low bidder confirmed in writing that the pricing for these items did not reflect the job required and requested to withdraw their Bid. The City's General Terms and Conditions do not permit withdrawal of a Bid after tender closing, but the City has the direction not to award to the lowest bidder, if such action is deemed to be in the best interest of the City.

**Dundas Power Line Ltd. (Recommended)

Staff recommends awarding the contract to the second lowest priced bidder Dundas Power Line Ltd.. Staff have carried out references on the recommended bidder and are satisfied that they can adequately carry out the Work and are recommending to proceed with Dundas Power Line Ltd.

Staff are able to reduce certain quantities within the bid document and come within budget.

PURPOSE

The purpose of this report is to obtain approval for the supply, delivery and application of liquid brine by tanker truck for two years at the same terms, conditions and pricing.

Note: In previous years, the City treated approximately 225 kms and we will now be treating 385kms, an increase of approximately 160 kms. Through this winter maintenance program, the City expects to utilize 352,062 litres of liquid brine per year at a cost of \$0.195/litre.

BACKGROUND

This contract is for the supply of a truck and operator to apply liquid brine for anti-icing on both City roads and structures (bridges, culverts) in one application on an as required basis. The contractor is to be available 24 hours per day 7 days a week throughout the duration of the contract. The contractor is required to be applying the liquid brine to the City's identified streets within one hour of being notified by the City's representative

Liquid Brine is a solution of salt in water that City utilizes as an anti-icing agent. The liquid brine prevents the bonding of snow to the pavement surface and assists in the effective plowing of the road surface. It is also a procedure used to prevent the formation of black ice and frost on road surfaces.

OPTIONS/DISCUSSIONS

The City purchases liquid brine in two different ways:

1. The City purchases liquid brine which is delivered to tanks at Miller Ave. Subsequently, the City then pre-wets the salt prior to its application to the road using both in-house trucks and hired contractors trucks (D. Crupi).

We are aware that there are only 3 companies who provide liquid brine in Ontario. Over the past 4 years, the City has issued quotes to these companies for the supply and delivery of Liquid Brine. On each occasion, Miller Paving Limited has been the lowest priced supplier

OPTIONS/DISCUSSIONS (Continued)

2. The City purchases the supply of a truck, liquid brine and operator to apply the liquid brine to the road surface. This methodology requires a tanker truck-sized vehicle in order to carry sufficient quantities of liquid brine. The vehicle must be able to carry enough liquid brine to be on the road between 8 -10 hours straight. The City does not own a vehicle of this size and it is not warranted since it would sit idle for the remaining part of the year.

The City issued a quote in 2012 for this requirement and only received one bidder, Miller Paving Limited. The reasons for not bidding by the two other companies was due to the following:

- They do not have a tank truck- sized vehicle
- The contract stipulates a service level requirement of 1 hour response time, which these two companies cannot meet due to their locations being greater than 1 hour from Markham. The one hour response time aligns to both in-house and hired staff who provide winter maintenance throughout the City.

ENVIRONMENTAL CONSIDERATIONS

Studies indicate that liquid brine spreads better then the road salt saving reducing the required amount of salt by about 20% and as a result, there being less environmental damage.

THAT the tendering process be waived in accordance with Purchasing By-Law 2004-341, Part II, Section 7 (2) (e) - Tenders, Requests for Proposal and Requests for Quotation may not be required for goods and services to be provided by any of the following: (e) Toronto and Region Conservation Authority (TRCA).

BACKGROUND

TRCA 50/50 Community Project Partnership Program

As part of the TRCA 50/50 Community Project Partnership Program, each partner contributes \$20,000 towards annual naturalization and riparian buffer planting projects to improve the ecological health, increase riparian tree canopy and native species biodiversity in the City's parks and natural areas within its two main watersheds. The program will improve water quality and fish habitat through the reduction of peak flow volume and soil erosion due to severe storm events. The program will link forest fragments to increase woodland cover and tree canopy in riparian buffer zones. The plan is to create corridors and habitat for wildlife in parks and valley lands across the City. The funds are used for the planning, site preparation and planting of native shrubs, trees and wildflowers.

BACKGROUND (Continued)

TRCA landscape architects work with Operations staff to conduct site assessments, develop planting plans, prepare planting beds, and supply native trees, shrubs and wildflowers for the planting projects. The principal objectives behind the plantings include: improve water quality and fish habitat through the reduction of peak flow volume and soil erosion due to severe storm events, link forest fragments to increase woodland cover and tree canopy in riparian buffer zones; create corridors and habitat for wildlife in parks and valley lands across the City.

Benefits

With few exceptions, the program's planting projects are located within TRCA screening zones. If plans were developed in-house by City staff then an application and permit approval would be required from TRCA's planning section. This partnership establishes a direct working relationship with TRCA staff for plan development to greatly reduce timelines and avoid consulting fee charges (estimated to exceed \$8,000), for this service outside of this partnership. Also, TRCA nursery stock is high quality and propagated from local seed sources and priced competitively with local wholesalers due to their cost recovery pricing. A potential source of donated trees over the next two or more years that could supply the trees for all planting projects of this program, has resulted in the need to review commitment to this program on an annual basis.

Giant Hogweed Control Program

TRCA will coordinate and oversee the application of chemical herbicide as required to control giant hogweed at all sites identified by the City within ravines on Markham parkland.

Benefits

There are multiple advantages for contracting the TRCA to provide Project management for all operational aspects of the Giant Hogweed Control Program. The most compelling reason to enlist the TRCA for this project is the fact that the bulk of the treatment applications or mechanical removals are confined to a watershed area under TRCA jurisdiction; their staff oversight will ensure that the ecological impacts of the control program will be kept to an absolute minimum. Moreover, the expertise and reputation of the TRCA should help to allay any public concerns about the safety or environmental impacts of the treatment program. In addition, the TRCA has the authority to effect treatment on any land, public or private, where the integrity or health of a watershed ecosystem is considered to be at risk.

The TRCA Managed Giant Hogweed Control Program includes all labour, vehicles, equipment and product. TRCA will field all questions and concerns from the public regarding treatment efforts, and to respond to these inquiries.

Also, all services provided by TRCA will be at cost with no profit mark-up.

Staff further recommends:

THAT as per Council resolution on June 8, 2010, the Chief Information Officer and Chief Administrative Officer be authorized to exercise the option to renew contract 339-R-09 for an additional five (5) one (1) year terms at 2.25% per year discount price for WAN connectivity services, and for the same cost as years 1 to 5 for internet services, subject to performance and budget approval.

AND THAT as per Council resolution on June 8, 2010, Rogers be designated as the preferred vendor for WAN connectivity needs for any future new or additional City of Markham sites during the term of the contract.

BACKGROUND

In 2009, the City of Markham awarded Internet Services and Wide Area Network (WAN) Connectivity via contract 339-R-09, with Staff recommendations for 40 Mbps Internet Service (which was later upgraded to 100Mbps) and a managed 1 Gigabit Fibre connectivity solution to connect 32 City and Library sites, as well as a managed 10 Gigabit Fibre connectivity for Civic Centre and 8100 Warden to Atria Networks (now Rogers). In addition, as part of the same award, a contract for 100 Mbps Internet Service was awarded to Bell Canada for the same term of five years with a similar option to extend for an additional five, one-year terms.

BACKGROUND (Continued)

The recommended fibre WAN connectivity has provided the Architectural and Technical viability needed in order to meet the increasing demands of delivering services to City customers. Accordingly, it has enabled the City to access key business applications faster across the network, and has positioned us to easily adopt technologies such as Voice over Internet Protocol (VoIP) for telecommunication, serving enterprise Geographic Information System applications over the internet, Closed Circuit Television (CCTV) and Supervisory Control and Data Acquisition (SCADA) capabilities for Waterworks, automated software deployment across the city, and for the Automated Vehicle Location (AVL) system for the City fleet.

In addition, the City has been and will continue to provide enhanced self-service capability through the portal including Recreation Program registration, audio (and content) streaming of all committee meetings to the public, and free wireless public internet access in selected City facilities, among others. In addition to internal staff needs to access higher bandwidth on a day-to-day basis to perform their duties, as the City continues to provide increased access to services through technology, the reliability and affordability of the technology infrastructure becomes increasingly important.

OPTIONS / DISCUSSIONS

WAN Services:

Since the change of ownership from Atria Networks to Rogers Communications Partnership (Rogers) in September 2011, Rogers has committed to honour the initial terms of contract 339-R-09. Accordingly, Rogers has agreed to renew the contract with 2.25% discount for year six (this award) as originally quoted by Atria Network.

Staff concluded that it is in the best interest of the City to renew the WAN Services with Rogers for the following reasons:

- 1. Rogers pricing continues to be very competitive compared to any other service provider, resulting in significant cost saving for the City
- 2. Rogers also has a proven track record with the City and has provided satisfactory service during the current term (2010 2015).

Negotiations are currently ongoing with Rogers regarding the cost for the additional/remaining four years that the contract can be extended to (excluding this award). Accordingly it has been confirmed that the prices are to be no greater than the current rates being paid for both WAN Connectivity Services and the Internet Services. Staff are investigating a proposed blended rate for the WAN Connectivity Services for the full extension of the contract, reducing the award amount from \$307,860 to \$297,458 (an annual savings of \$10,402 or 3.4%).

Internet Services:

The City's demand for Internet access has been steadily increasing over the past few years. A number of departments have mission critical systems offered through Cloud Services that cost-effectively manage and distribute software-based services and solutions over the Internet. Cloud Services used at the City include: Payroll/HR system, HR recruitment, Ticketing system for Markham Theatre and Teraview for title search used by Legal Department. These departments would not be able to use these applications if the Internet service was not available or interrupted.

Staff also recommends to renew the Internet service contracts with Rogers as the primary connection providing 100 Mbps of bandwidth, and with Bell Canada as a secondary link with 100 Mbps of bandwidth. Having multiple service links with different vendors have allowed for internet access for priority services to be separated and/or rerouted in order to guarantee that sufficient bandwidth is available for those services. The cost for these service renewals is included within the existing ITS operating budget.

It is recommended that the WAN and Internet service contracts be renewed for the optional one-year term with both Rogers and Bell, as per the contract 339-R-09.

BACKGROUND

The Don Mills Channel is a modified watercourse constructed in the 1970s to facilitate industrial/commercial development on the east side of Highway 404, south of the CN Railway (Ward 8). The area has experienced flooding several times, with damages being reported by various businesses.

A preliminary evaluation of the study area was previously completed by the City, with information being presented to council in 2007 and 2009. In late 2009, the City put the study on hold to conduct a City-wide stormwater funding study to establish funding sources for flood control works. Given that the funding study is now completed, the City is now in a position to re-initiate the Class Environmental Assessment process.

As part of the development of the stormwater fee, the following resolution was provided by Council in February 2013:

"That the City's flood control strategy adopt a 5 year level of service target for Don Mills Channel drainage system based on its original design and consider other options, subject to technical feasibility and approval as part of a future Class EA."

As part of this study, various alternatives will be developed and evaluated to reduce the risk of flooding in the study area using the most modern analysis methods available. A preferred alternative will be selected through this process, with a preliminary design of this alternative being created for public review. It is expected that one or more future construction projects will be recommended through the Environmental Assessment process.

In selecting and evaluating flood reduction alternatives, City Staff will establish a liaison committee and technical advisory committee made up of various stakeholders, including representatives from regulatory agencies, landowners and local business owners, and other members of City staff and the public. In addition, two Public Information Centres will be held to inform the public of the project progress and to receive feedback on the preferred alternatives.

PROPOSAL EVALUATION

The Evaluation Team was comprised of staff from the Asset Management department and facilitated by staff from the Purchasing department. Due to the complexity of the project, staff wanted to ensure that bidders had the necessary qualifications and experience to carry out the work and as such, the City released this RFP utilizing a two-stage, two-envelope system.

Stage One (1) – Technical Evaluation:

Under Stage 1 – Technical Evaluation (Envelope 'A'), Bidders were assessed against pre-determined criteria as outlined in the RFP; Experience/Past Performance of the consulting firm 20%, qualifications and experience of the project manager and team member 15% and project delivery 30% totaling 70%. Bidders that did not achieve a technical score of 52.5 points out of 70 would not proceed any further and their Envelope B – Price Evaluation would be returned unopened.

Stage Two (2) – Price Evaluation:

Under Stage 2 – Price Evaluation (Envelope 'B'), Bidders which met the mandatory requirements and achieved a total technical score of 52.5 points or greater out of 70 points were assessed out of 30 points based on their Bid Price. The highest ranked bidder was determined by adding the points awarded under Stage 1 – Technical Evaluation and Stage 2 – Price Evaluation.

Staff are confident that their approach will meet the study requirements and objectives.

Price submissions ranged from \$186,000 to \$438,000 (Inclusive of HST).

BACKGROUND

As part of the street-scaping improvements on Main Street Markham North, between Highway 7 and Bullock Drive, the City installed interlocking concrete pavers on the roadway throughout the intersection at Robinson Street and Main Street Markham North. In an effort to further enhance the roadway; interlocking concrete pavers were also used to delineate the crosswalks at Centre Street and at a mid-block pedestrian crossing just north of Wilson Street.

Crosswalk bricks have prematurely failed and are sinking or popping out. The sinking bricks are affecting surrounding asphalt and roadway brick areas. The remedial work identified in this is to address safety concerns for pedestrians and vehicles.

The scope of work involves the removal of the existing brick pavers to top cement base and restore area with colour impressed asphalt.
