It was thought that Committee members might work with Francine Perinet, Director Varley Art Gallery, to develop criteria and initiate planning discussions. Chair Matthew Korchinski will contact John Ryerson to explore these ideas. Other initiatives such as updating the Committee's art brochure and arranging temporary displays of art, will also be explored.

#### **A) Presentation**

Ms. Linda Irvine, Manager of Parks and Open Spaces, presented pictures taken of Chicago while attending the annual conference of the American Society of Landscape Architects.
