

THE CORPORATION OF THE TOWN OF MARKHAM

BY-LAW NUMBER _____

TO AMEND BY-LAW 106-71

BE IT ENACTED BY THE COUNCIL OF THE CORPORATION OF THE TOWN OF MARKHAM THAT BY-LAW NUMBER 106-71 BE AND THE SAME IS HEREBY AMENDED AS FOLLOWS:

1. That Schedule 19 of Traffic By-law 106-71, pertaining to “Traffic Control Signals”, be amended by adding the following locations for authorized traffic control signal system:

COLUMN 1
INTERSECTION

Highway 48 and Castlemore Avenue

Highway 48 and Bur Oak Avenue

Old Kennedy Road and Aldergrove Drive

South Town Centre Boulevard and Clegg Road

Henderson Avenue and Proctor Avenue / Glen Cameron Road

2. That Schedule 12 of Traffic By-law 106-71, pertaining to “Compulsory Stops”, be approved by deleting the following locations:

| Henderson Avenue at Proctor Avenue | Eastbound on Glen Cameron Road | South side of Glen Cameron Road, on the West side of Henderson Avenue |
| Henderson Avenue at Proctor Avenue | Westbound on Proctor Avenue | North side of Proctor Avenue, on the East side of Henderson Avenue |
| Old Kennedy Road at Aldergrove Drive | Westbound on Aldergrove Drive | North side of Aldergrove Drive, on the East side of Old Kennedy Road |

| South Town Centre Boulevard at Clegg Road | Westbound on Clegg Road | North side of Clegg Road, on the East side of South Town Centre Boulevard |
| South Town Centre Boulevard at Clegg Road | Eastbound on Clegg Road | South side of Clegg Road, on the West side of South Town Centre Boulevard |

3. The By-law shall come into force and effect upon receiving the third reading by the Council of the Town of Markham and also when authorized traffic control signals have been energized.
4. All other provisions of By-law 106-71 which have not been hereby amended shall remain in full force and effect.
