## HERITAGE MARKHAM RECOMMENDS:

THAT Heritage Markham recommends that Council pass the following resolution:

Whereas according to the Heritage Canada Foundation, Canada has lost more than 20% of its pre-1920 heritage buildings to demolition over the past 30 years;

Whereas the Heritage Canada Foundation has stated that urgent action is needed to stop the demolition of Canadian landmarks, to restore and re-use them, and to acknowledge their value as a reminder of our origins and cultures;

Whereas heritage buildings are also a valuable economic development resource, which support re-urbanization initiatives and tourism, stimulates adjacent development, increase property values, all while providing environmental benefits by way of reducing landfill, preserving natural resources and promoting sustainability;

Whereas there are currently no federal financial incentives to encourage private sector investment in the rehabilitation of heritage properties; and

Whereas Heritage Markham, Council's heritage advisory committee, has requested that the Town of Markham pass a resolution requesting the Federal government to introduce financial incentives which would encourage private sector investment in the rehabilitation of historic properties;

Be it resolved that the Corporation of the Town of Markham endorse resolutions by the Heritage Canada Foundation and the Federation of Canadian Municipalities that request the Federal Ministers of Finance and the Environment to establish tax incentives which would encourage private sector investment in the rehabilitation of heritage properties;

That his motion be forwarded to local Members of Parliament and area municipalities for their support;

That the Association of Ontario Municipalities support the work of the Heritage Canada Foundation and the Federation of Canadian Municipalities regarding the need for federal tax incentives by endorsing a resolution at its Annual Convention;

That Staff be authorized and directed to do all things necessary to give effect to this resolution.

PROPOSED NEW RESTAURANT DECK (16.11)

The Heritage Planner explained that staff had not supported the original proposal and had made recommendations to the applicant regarding the deck height and retention of the historic veranda railing. The applicant has submitted revised drawings which are supported by staff, and which were presented to the Committee. The Committee requires that any previous deficiencies be corrected as a condition of approval.

#### HERITAGE MARKHAM RECOMMENDS:

THAT Heritage Markham supports the proposed deck for 202 Main St., as revised (January 14, 2009), with the condition that previous deficiencies are corrected;

AND THAT Heritage Markham does not object to the creation of a new doorway off the modern addition to 202 Main St.

BRIDGE REHABILITATION
CARLTON ROAD
MAIN STREET UNIONVILLE (16.11)

The Senior Heritage Planner advised that the bridges on Carlton Road and Main Street Unionville are proposed to be modified to meet new safety standards. Staff had some concerns with the aesthetics of the plans presented by Asset Management staff, and the Committee was in agreement with their concerns. The Committee also expressed concern that the Ward Councillor had not been consulted by the Asset Management Department – Capital ROW.

## HERITAGE MARKHAM RECOMMENDS:

THAT Heritage Markham does not support the proposed guard rail installation and modifications to the stone-faced bridge parapet as they are not aesthetically satisfactory in the context of the Unionville Heritage Conservation District;

AND THAT the Asset Management Department look into alternatives for the installation of the guard rail that will not impact the aesthetic appearance of the bridge, taking into consideration that traffic speed is quite reduced in this area due to the existence of a fourway stop and the road configuration;

AND THAT the Ward Councillor be consulted on the proposal by Asset Management Department – Capital ROW staff.

SEVERANCE APPLICATION (16.11)

The Manager of Heritage Planning explained the history of this proposal. A previous application to create two new lots (three in total) had been denied by the Committee of Adjustment and the Ontario Municipal Board. The applicant has now revised the proposal to create one new lot (two in total) both of which would comply with lot frontage and area requirements. In addition to proposed conditions, the new houses will be subject to Site Plan Approval and review by Heritage Markham.

### **HERITAGE MARKHAM RECOMMENDS:**

THAT Heritage Markham has no objection to the proposed severance of the property at 60 Rouge subject to the following:

- significant vegetation being retained including the coniferous trees on the Rouge Street frontage of the property;
- any proposed new dwellings on the retained and severed lots comply with existing maximum lot coverage requirements and maximum net floor area ratio requirements to ensure that the dwellings are complementary to the scale and massing of other dwellings in the immediate area.
- ➤ That the dwelling for the Rouge Street lot have its front elevation facing Rouge Street.
