
Figure 1 – Location Map

Dear Neighbours

You may have heard that Bell Mobility has approached our congregation about putting up a cell phone tower on the church property. They intend to locate a new tower in the neighbourhood, as they feel it is needed for their services. Although there could be other possible locations, they have asked the congregation to lease them land for the tower.

The Rouge Valley Mennonite congregation has met together twice to discuss Bell's proposal. At those meetings, the congregation discussed the appearance and safety of the tower and dispersal of the potential rental income. The congregation agreed to view the rental income as a positive opportunity for sharing and promoting other service projects or ministries.

The tower would be located at the south-west corner of the property (near the propane tank). It would be a plain white pole, 32 metres tall, like an extra-thick flagpole. Nothing would be attached to the pole. There would be a small service shed beside it. The shed will be mostly hidden by the slope of the property and will be landscaped to blend with the church.
