<b>1. Call to Order</b>	The Animal Care Committee convened at 5:41 p.m. with Denielle Duncan presiding as Chair. New members were welcomed and introductions were made.

<b>4. Animal Control Services</b>	<p>Christopher Alexander provided the following updates on Markham's Animal Control Services:</p> <p><u>Trap Neuter and Return</u> Christopher Alexander reported that there are a number of feral cats in the Markham Road/Denison Avenue area. Markham is trapping one or two each day. Since not everyone wants the cats in the community, each situation is handled on a case by case basis. He plans to hold a seminar about this program in fall 2015.</p> <p><u>Barn Cats</u> Christopher Alexander reported that Markham is requesting program information from other municipalities to be used to implement a similar program by spring 2016. Committee members advised that such a program must have criteria for the barns in order to protect the cats. Christopher Alexander reported that, in September, the Committee could form a sub-committee to assist in developing the criteria for the program. Esther Attard will share the guidelines for the Toronto program with Christopher Alexander.</p> <p><u>Cat and Pet Education Centre</u> Christopher Alexander reported that, at its June 23<sup>rd</sup>, 2015 meeting, Council unanimously approved the establishment of a Cat Adoption and Education Centre (CAEC) in the Thornhill Community Centre and Library. The CAEC will focus on the promotion of cat adoptions, which will help to decrease the euthanasia rate. In addition, the CAEC will promote joint initiatives with Community programs, such as reading therapy programs in conjunction with the library, education programs on animal welfare, volunteer programs for residents and students, including those enrolled in veterinary technician programs. The CAEC will be a temporary home to a maximum of 17 cats at any given time and the cats will be spayed or neutered and receive up to date vaccinations. Opening of the CAEC is anticipated for fall 2015 depending on the timing and completion of renovations. Councillor Valerie Burke extended the appreciation of Council for the Committee's donation of \$30,000 towards the project.</p> <p>Animal Services plans to create branding and advertising for the CAEC. Councillor Valerie Burke reported that some members of the public think of the CAEC as an animal shelter; it will be important to properly brand the CAEC as an adoption and education centre.</p>	Meeting on Monday, July 27 at 6:00 pm in the Ontario Room to discuss fundraising ideas for the Cat Adoption and Education Centre (CAEC).

	<p>The Committee discussed whether to offer space, as available, to animal rescue groups in order to maintain maximum capacity at the CAEC; members expressed concern that differences in hygiene practices might expose cats to unwanted health issues. This issue will be researched and discussed further.</p> <p><u>Fundraising for the CAEC</u></p> <p>Christopher Alexander reported that he will be discussing this matter with Corporate Communications. There will be roles for interested stakeholders such as members of this Committee and OSPCA. It was suggested holding a separate meeting to discuss fundraising ideas for the CAEC; it was agreed to hold the meeting on Monday, July 27 at 6:00 pm in the Ontario Room.</p>	<p>Volunteers and sponsors for the centre will be welcomed. Chair Denielle Duncan provided information to Christopher Alexander about a potential volunteer and potential sponsor. It was suggested that it would be helpful to have a local photographer donate services to take quality pictures of the cats to be adopted. It was reported that Rhiannon Lane may offer design services, Councillor Valerie Burke can advertise in her newsletters and on Facebook, and Christopher Alexander will work with Corporate Communications to develop a website.</p>	<p>Email to request volunteers to participate at the Dog Days event on August 9, 2015.</p>
