| 4. Animal Control Services | <p>Christy Lehman provided the following updates on Markham's Animal Control Services:</p> <p><u>Trap Neuter and Return</u></p> <p>It was reported that there are approximately thirty feral cats in the McCowan Road/ Denison Avenue area. Markham is trapping one or two each day and plans to relocate them gradually to a few barns in the Claremont area. Some cats are young; it is hoped that they may be tamed and then adopted. It was also reported that another colony of cats has been located in an industrial area in the Yonge St./Steeles Ave. area.</p> <p><u>Barn Cats</u></p> <p>Christy Lehman reported that Markham needs to place thirty cats. Markham plans to develop guidelines once the CAEC is closer to being ready. In the interim, Markham takes care when relocating a cat to a barn since Markham does not want to place a cat in an environment where it would not do well. Committee members would be welcome to assist in developing criteria to assess barns in order to provide the cats with a safe environment. Esther Attard will share the Toronto program guidelines with Christopher Alexander.</p> <p><u>Cat and Pet Education Centre</u></p> <p>Christy Lehman reported that Markham has hired a consultant to create branding and advertising for the CAEC as an adoption and education centre. She is creating a large donation bin to be placed at the community centre.</p> <p><u>Fundraising for the CAEC</u></p> <p>At the meeting held on July 27, Committee members developed a number of fundraising ideas for the Cat at the Adoption and Education Centre (CAEC). | 5. Events | <p>Chair Denielle Duncan reviewed the Dog Days event at the Stiver Mill Farmer's Market on August 9, 2015. She mentioned that the Animal Care Committee was not assigned a booth in a prime location, and as a result, there were few opportunities to share information about the Committee's activities with attendees. Because this problem has been experienced in the past, the Committee discussed whether to continue participating at this event. It was agreed that Chair Denielle Duncan would approach the Dog Days event coordinator to discuss the location of the Committee's booth. If the Committee were to be assigned a better booth location, the Committee may consider participating once more before the closing of the outside market for the winter months.</p> <p>It was reported that a member of the public may have been discussing Committee activities and the new CAEC with Dog Days event attendees. K. Tung advised that he had done so. It was advised that the Committee welcomes volunteers and asked K. Tung to work with the Committee to ensure that messages shared with others are correct.</p> <p>The Committee discussed whether to attend the Thornhill Village Festival which will not feature a parade this year. The Committee agreed to attend this event. Chair Denielle Duncan will ask Pushgroup Brar and Rhiannon Lane to coordinate volunteers and materials for the event.</p> <p>Christy Lehman reported that Markham is considering hosting the Markham Bark Walk in spring 2016 to encourage residents to license their pets. Committee members expressed concerns about an aggressive vendor and suggested combining a licensing event with a rabies clinic.</p> <p>Julie Chan reported that the Peace for Paws group is hosting a 5 km walk on Sunday September 13 starting at the Pet Valu store at 7355 Bayview Avenue (at Laureleaf Road).
