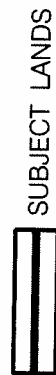

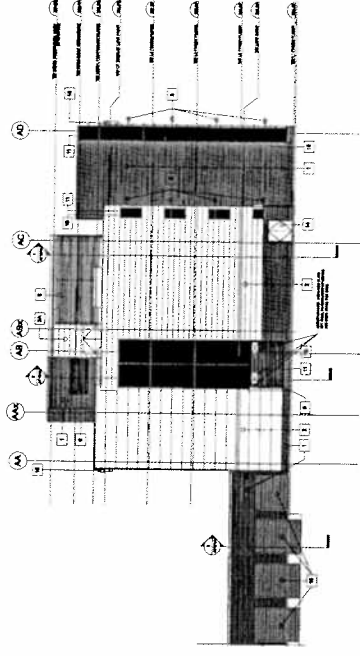
SOUTH ELEVATION

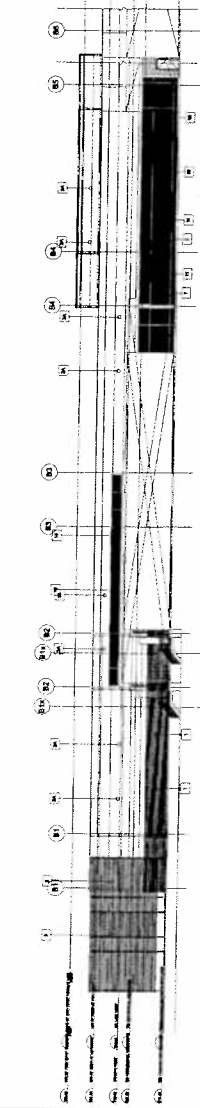

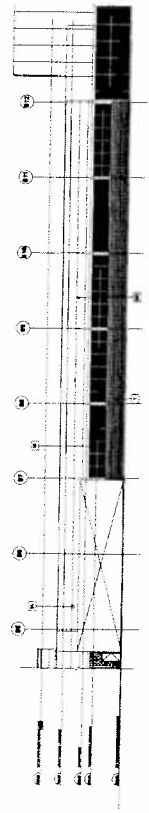

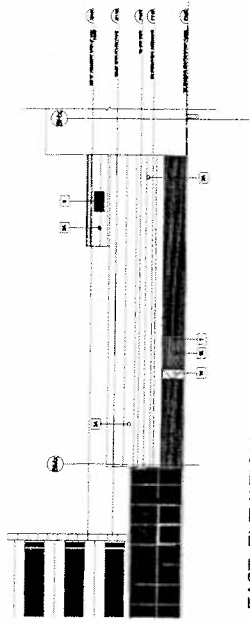

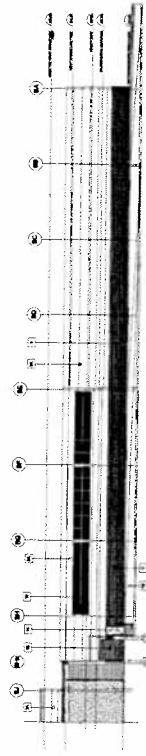
SOUTH ELEVATION (WEST PART)



SOUTH ELEVATION (EAST PART)

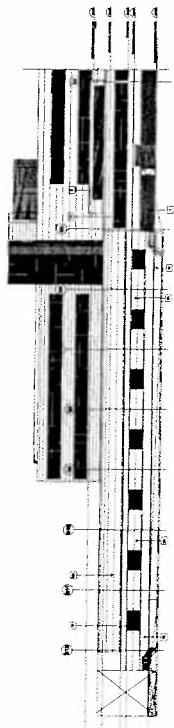


EAST ELEVATION (SOUTH PART)

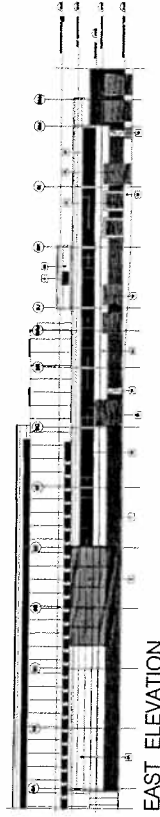

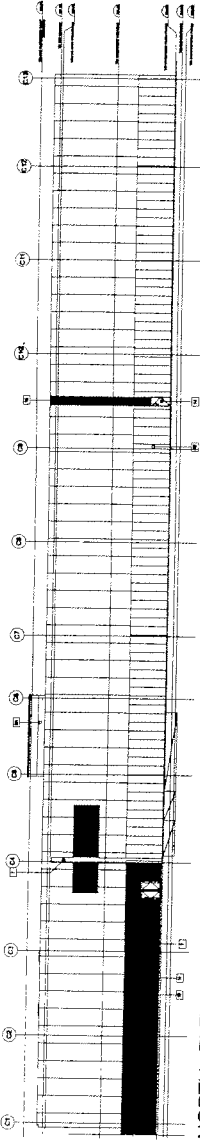

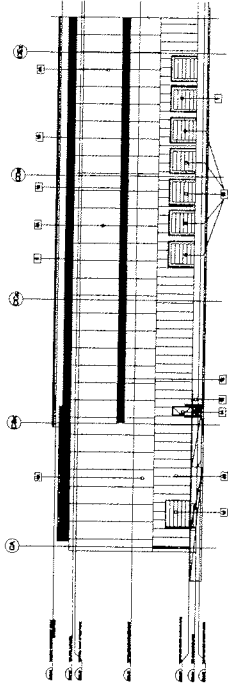
PDC EAST & NORTH ELEVATIONS

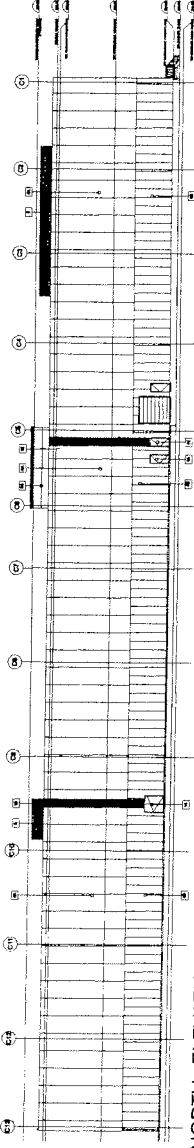


EAST ELEVATION (SOUTH PART)

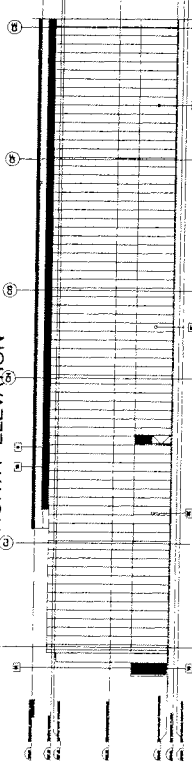

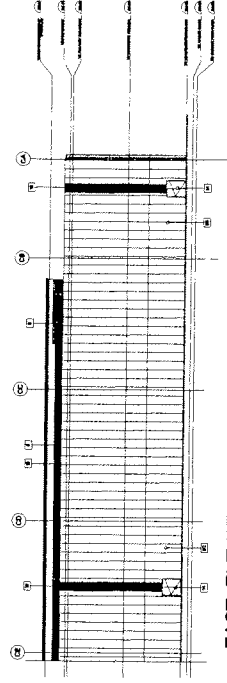
