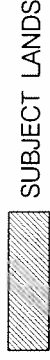

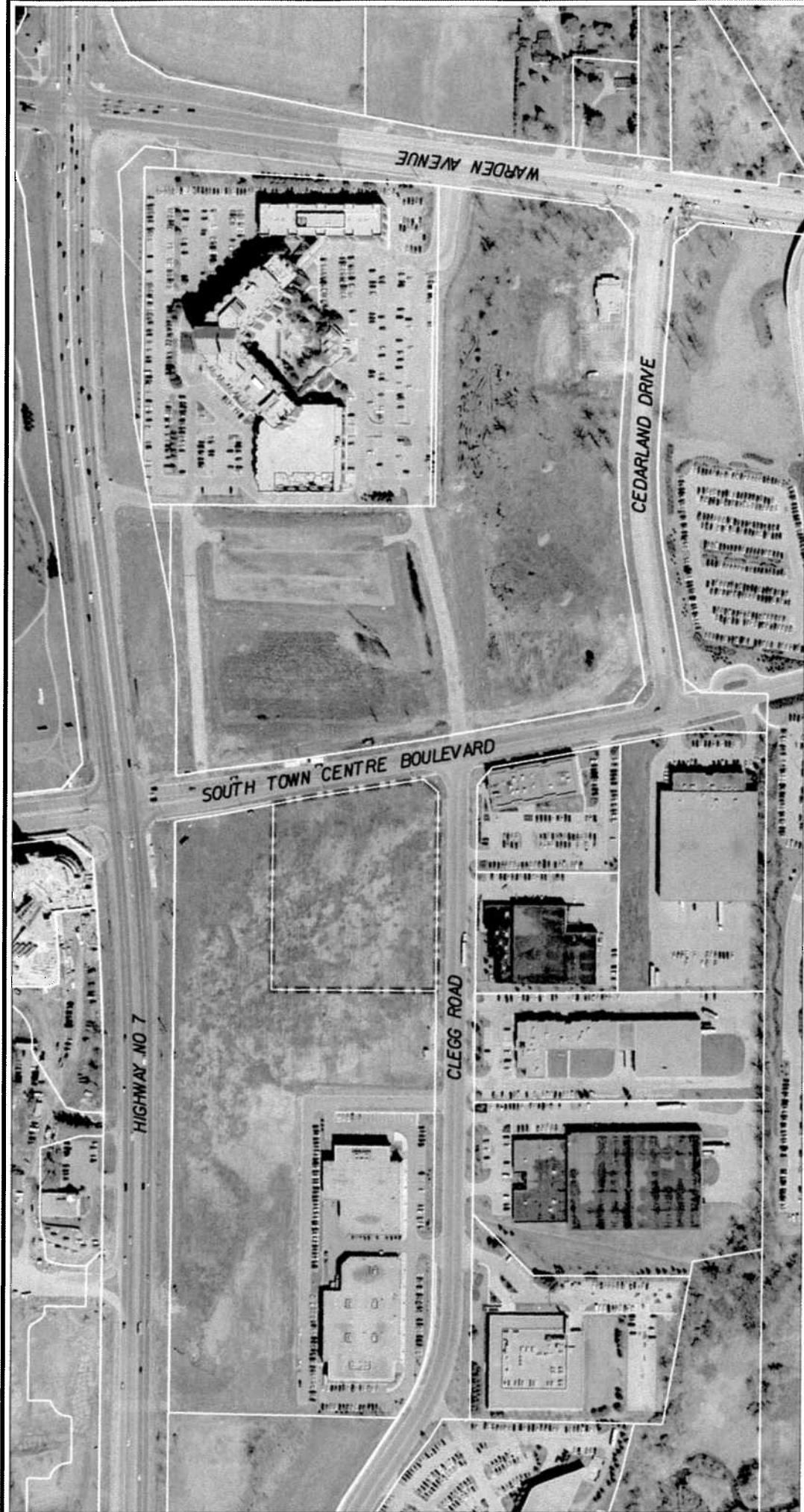

SUBJECT LANDS



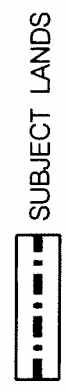

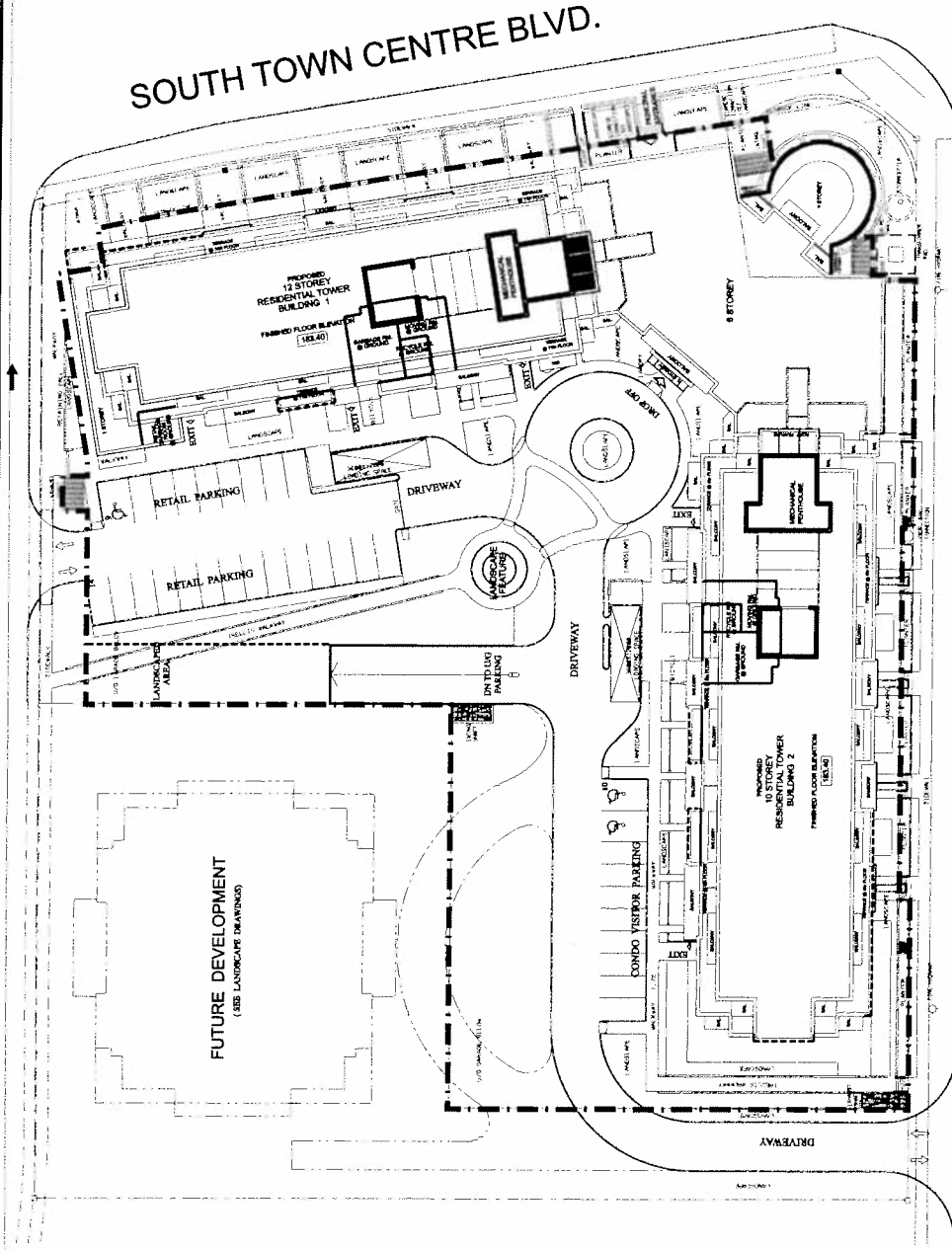

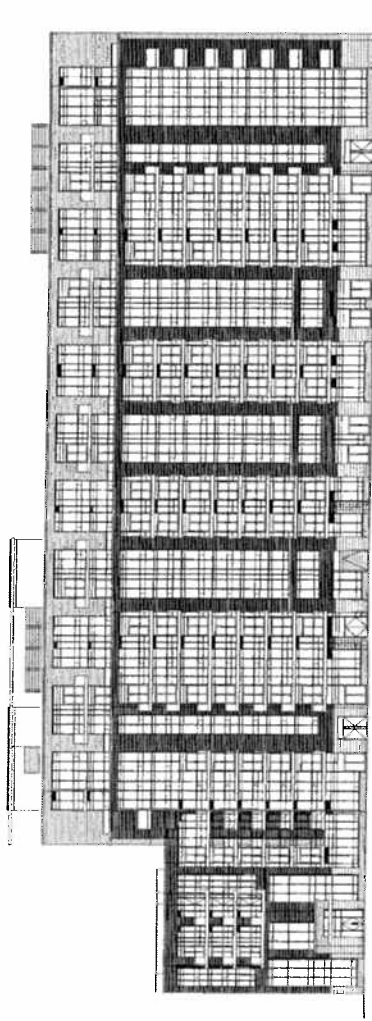

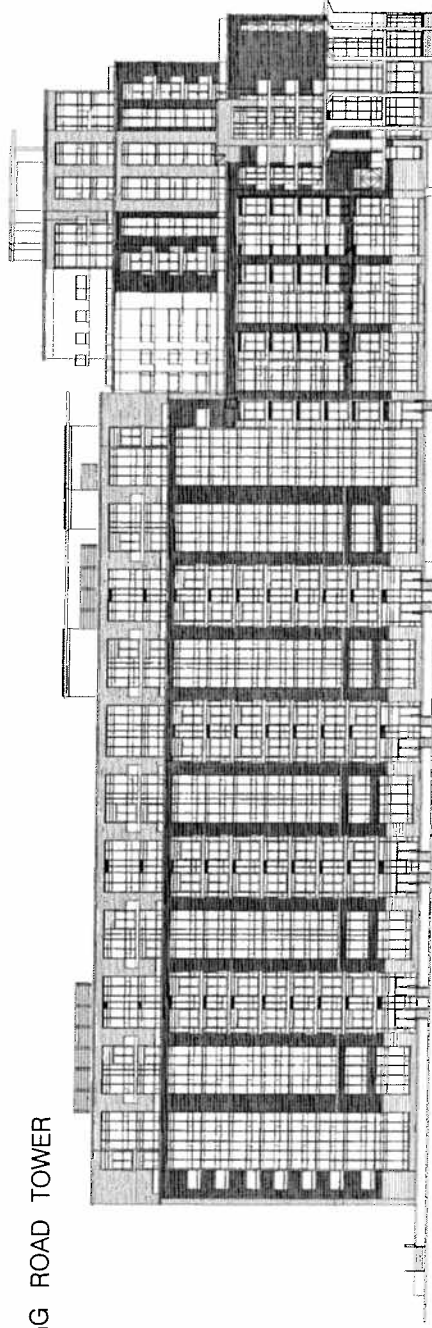

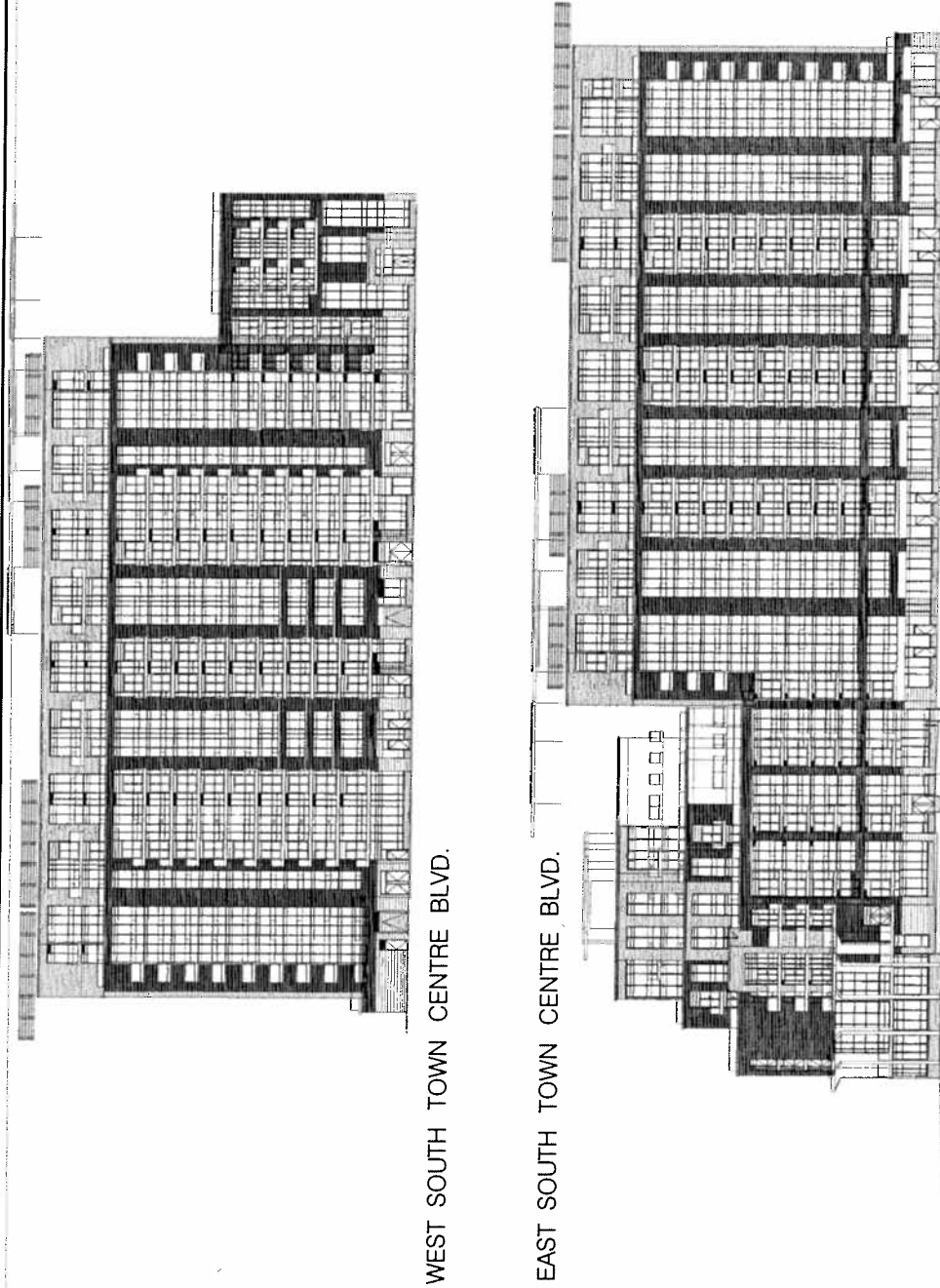

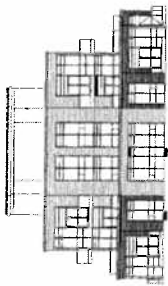

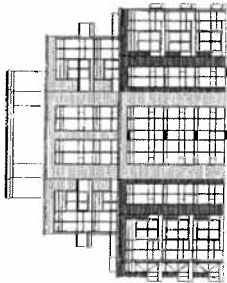

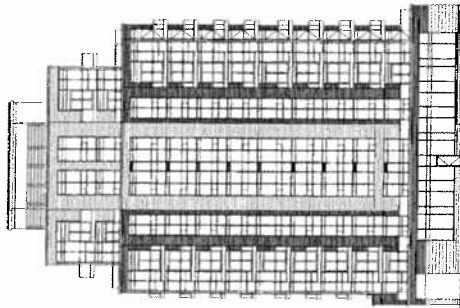

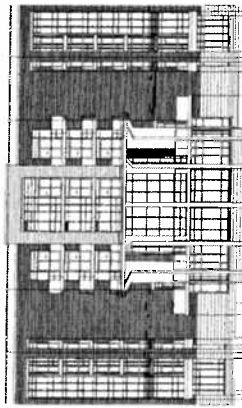
EAST CLEGG ROAD TOWER



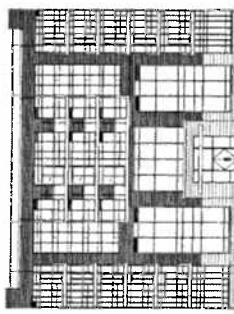

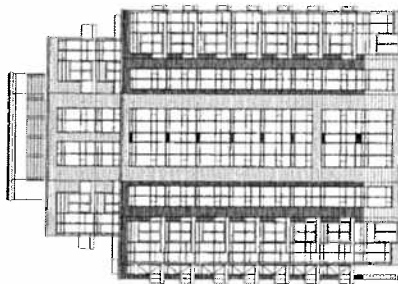
