# 8. DIRECTOR'S REPORT- Cathy

Cathy Molloy presented to Board:

- Very successful grant application of \$150,000
- John advised that in discussion with an official from another municipality he learned that in their
  process the building capacity for people is determined as part of the building permit approval
  process. Since the Board was surprised to learn of the capacity limitations within the new
  building only after it was completed, he suggested that it might be appropriate for the Town to
  review its processes

Committee briefly talked about design of building and its capacity level Edmond Li suggested looking back at specs of building to determine if different capacity numbers were projected.
