3. Animal Control Store Front	The Committee reviewed the action items from the previous meeting. Trinela Cane, Commissioner of Corporate Services, was in attendance to discuss planning for the proposed Markham Animal Storefront. The plan is for the OSPCA to operate the storefront under the direction of the City. Many volunteers would be required to operate the storefront. Any donations collected at the storefront will support the Markham's Animal Services program. The storefront will have mostly cats, but on special days it could have dogs, and smaller pets. The City is hopeful that the storefront will reduce cat euthanasia rates in Markham.	Staff is assessing the potential to locate the storefront at the Thornhill Community Centre. Formal consultation with users of the Centre, staff and other stakeholders will begin shortly. The

The Community Centre would have lots of traffic, which staff feel is critical to the success of the storefront.</p> <p>The Committee was very positive about the storefront. It made the following suggestions:</p> <ul style="list-style-type: none"> • Ensure younger volunteers are being monitored by adult volunteers; • Consider partnering with schools to fill some of the volunteer positions; • Consider providing wildlife education at the storefront; • Consider doing a calendar with the firefighters and animals to raise funds for the storefront; <p>There was a discussion on the North Toronto Cat Rescue.</p>
