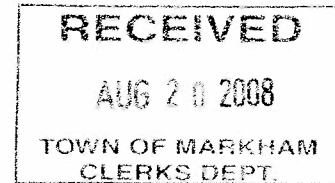

**Re: Replacement of Municipal Representative For  
Source Protection Committees As Required By The  
*Clean Water Act***

The Council of The Regional Municipality of York, at its meeting held on Thursday, March 27, 2008, adopted, without amendment, the attached Clause No. 4, Report No. 3 of the Transportation and Works Committee.

By the adoption of the foregoing clause, Regional Council has authorized the following:

1. Regional Council appoint Neil Garbe as the Municipal representative for York Region and its constituent local municipalities on the Credit Valley, Toronto Region and Central Lake Ontario Region Source Protection Committee.
2. Regional Council appoint Erin Mahoney as the Municipal representative for York Region and its constituent local municipalities on the South Georgina Bay-Lake Simcoe Source Protection Committee.
3. The Regional Clerk forward a copy of this report to the Clerks of the nine local municipalities of the Region, the South Georgina Bay-Lake Simcoe Source Protection and the Credit Valley, Toronto Region and Central Lake Ontario Region Source Protection Authorities.
4. Regional Council request the nine local municipalities to endorse the appointment of Neil Garbe and Erin Mahoney as the applicable Municipal representatives on the Credit Valley, Toronto Region and Central Lake Ontario Region Source Protection Committee and the South Georgina Bay-Lake Simcoe Source Protection Committee.
