



CSIO Feasibility Study Catchment Area


Aquatic Centre, Ground Floor Plan


Field House, Ground Floor Plan














Option 2 – Open Channel Along South & East **Boundary of CSIO** Appendix F



1.	Plan articulates 11 strategic priorities in order of importance. The 8 th priority is "feasibility of a large recreational facility of Regional draw". "Markham residents believe the community should develop a world class sports facility capable of handling tournaments & meets".	Proposed facility design components are consistent with this priority.	Specifically, the public expressed interest in facilities such as an Olympic sized pool and arena with seating. 6.	The plan recommends that the Town explore partnership opportunities that would offset the funding requirements to provide facilities and programs. 7.	The plan identifies Phase 1 (2009) of Southeast CC to include one new arena and a replacement of one existing arena. In Phase II (2014) identifies one more new arena and a replacement of another existing arena.	CSI would provide the two new arenas identified as a need from 2009 – 2014.	The land acquired in the Southeast is approx. 30 acres. Area required for the arenas is substantial. If not put on this site some of the land could be considered for outdoor rec fields/sports. The two potential replacement arenas may require additional land acquisition depending on final resolve to the issue and timing.

8. The Southeast CC proposed by 2014 is recommended to contain fitness space, indoor swimming pool, gymnasium and dedicated programming space.	CSI would provide the identified need for all of fitness space and an indoor swimming pool, and a portion of programming needs related to the gymnasium.	The Southeast CC is still required to provide a community focal point. With the addition of CSIO to the inventory of indoor recreation facilities in the Town, the planned components and timing of the Southeast CC will require reevaluation including public consultation.
