THE GTA/905 REGION – BY THE NUMBERS

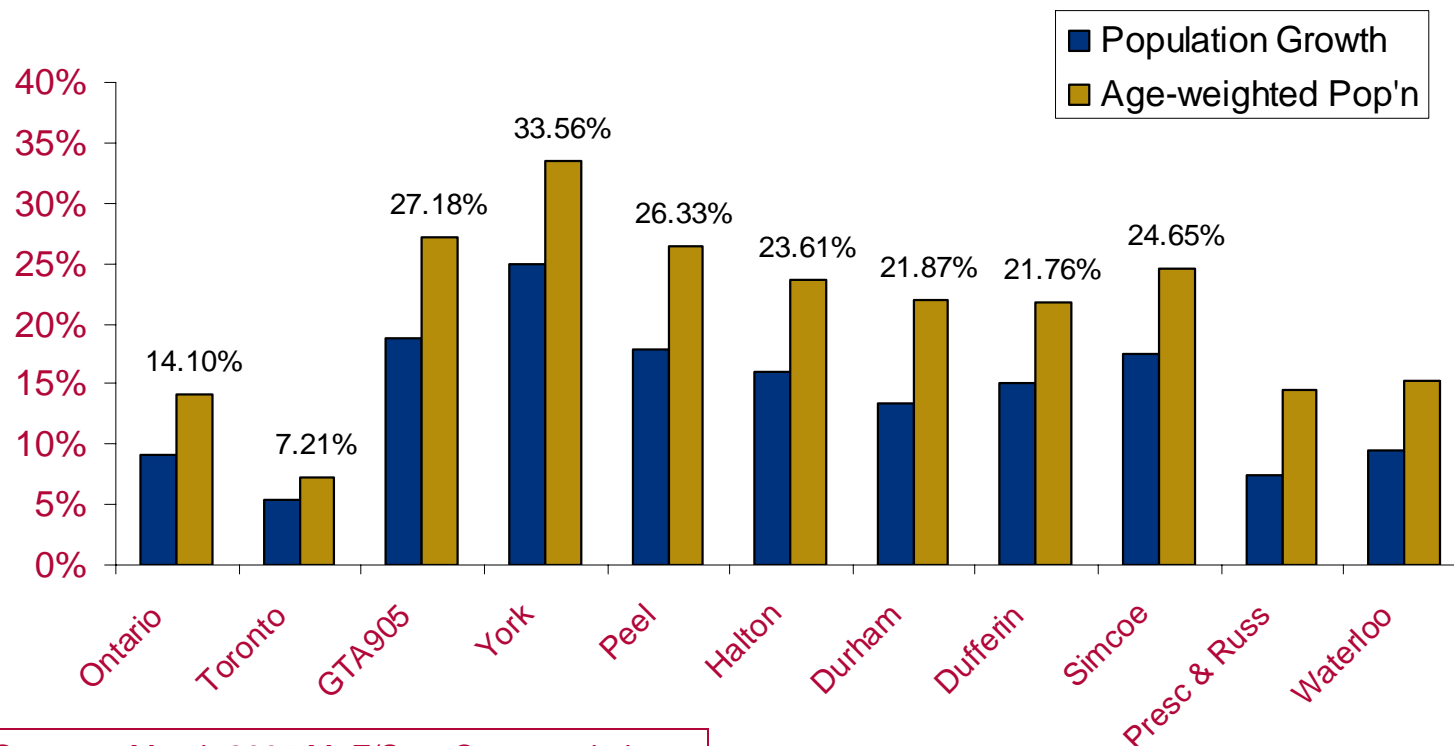
- Over 3 million residents reside in the GTA/905 Regions of Peel, Durham, York and Halton.
- Represents 25 percent of Ontario residents.
- Grows by 100,000 residents each year (like dropping the residents of Kingston into the GTA/905 region each year)

2004 – 2011: GTA/905 continues to outpace rest of Ontario



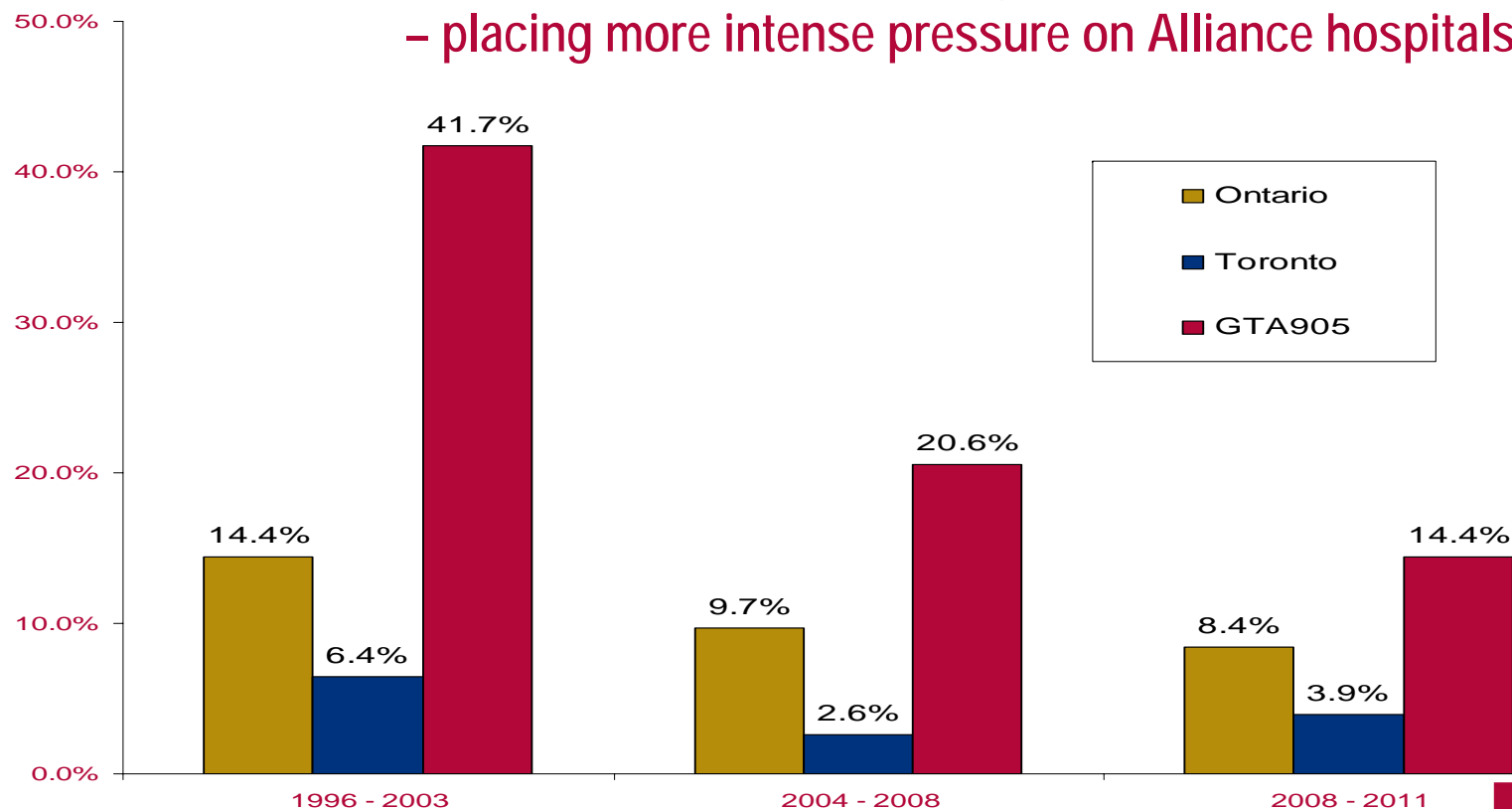

– placing more intense pressure on Alliance hospitals.



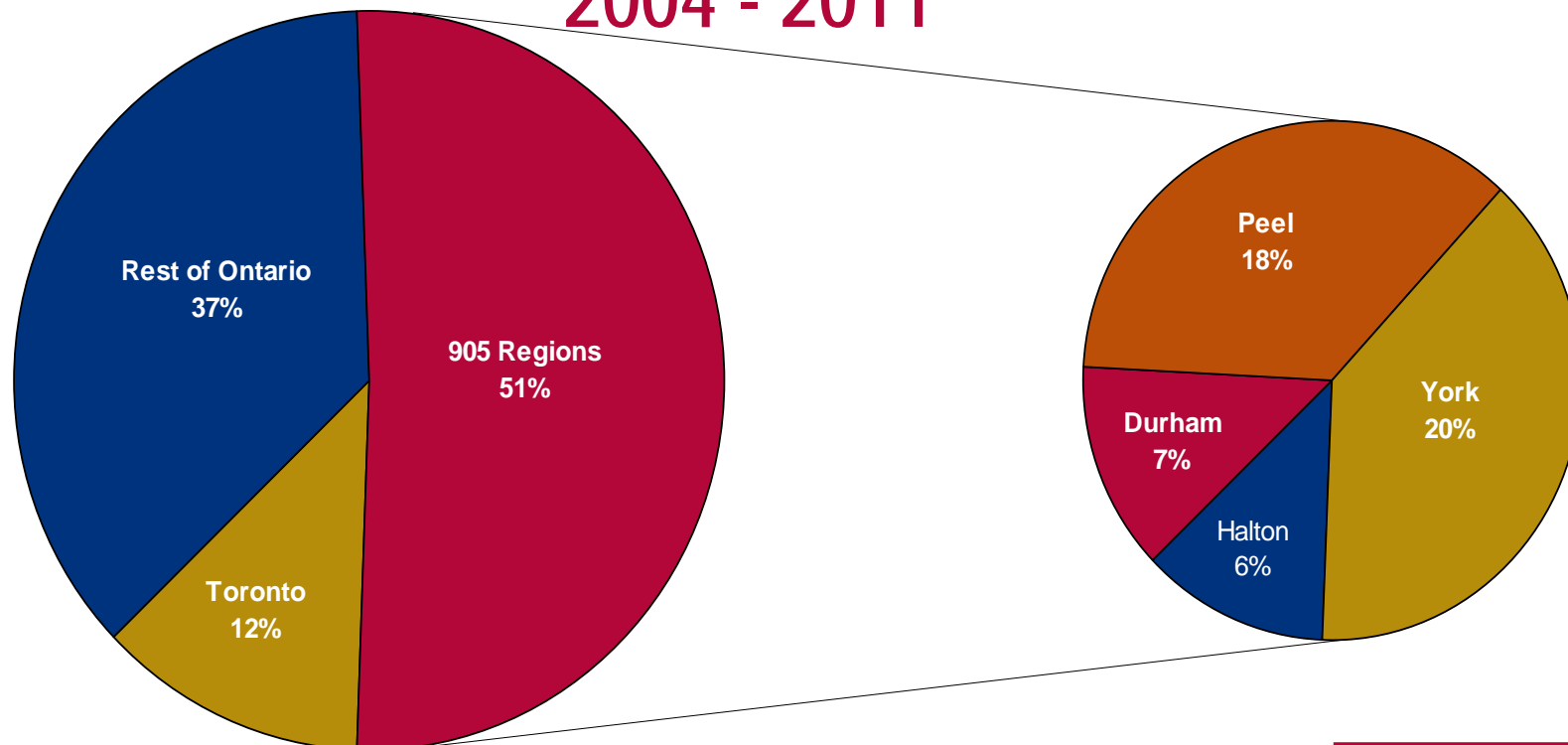

WHERE WILL YOU GET CARE?

The Localization Index (LI) shows percentage of LHIN residents receiving hospital care within the LHIN (i.e., “close to home”).

GTA/905-related: 66%

Rest of Ontario Average: 89%

What are the issues?

WHEN WILL YOU GET CARE?

Findings:

- For 9 of 12 procedures, GTA/905 residents have rates of access that are lower than provincial average
- For another 9 of the 12 procedures, GTA/905 residents have rates of access that are lower than Northern Ontario
- GTA/905 residents are also waiting: 4 were longer than provincial average, two were at the provincial average, 4 were only slightly shorter.

HOW WILL YOU GET CARE?

“The result is that GTA/905 residents are waiting longer for services, or they are forced to leave their communities to access services, or they are simply going without services, until their circumstances spiral out of control and they require costly interventions by the health, child welfare and criminal justice systems.”

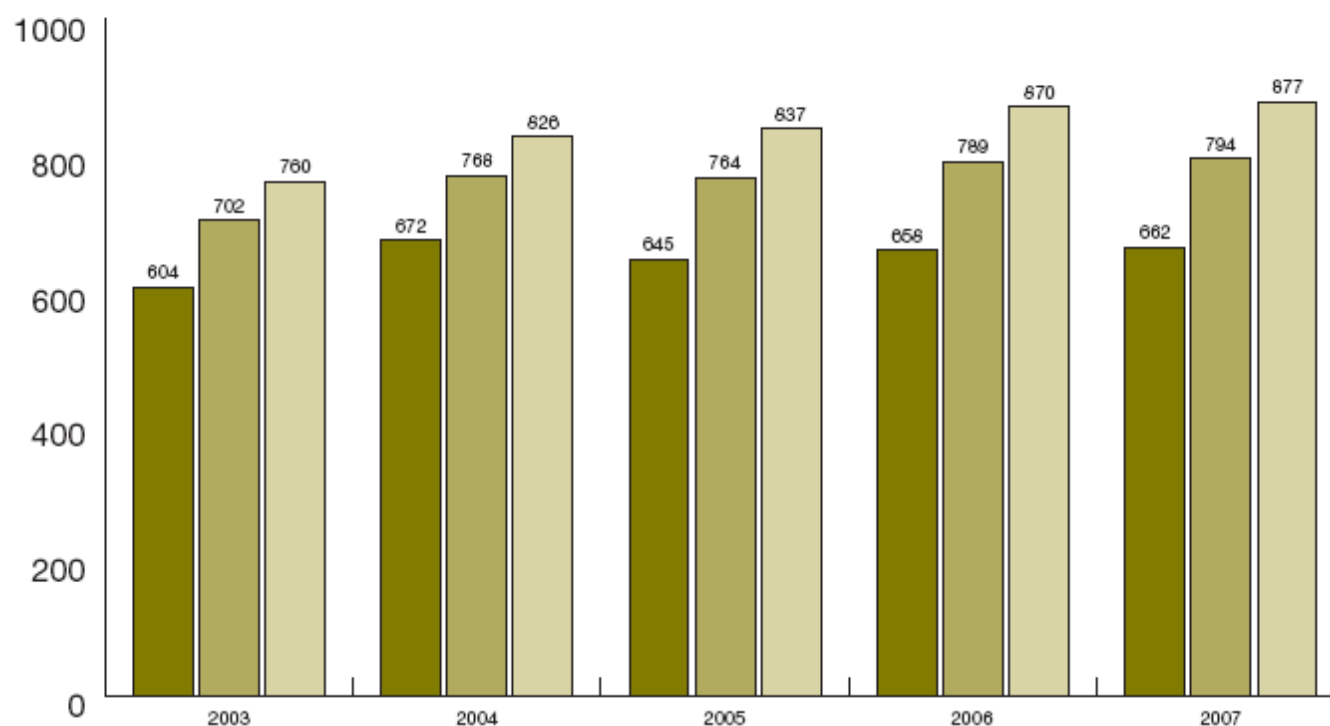

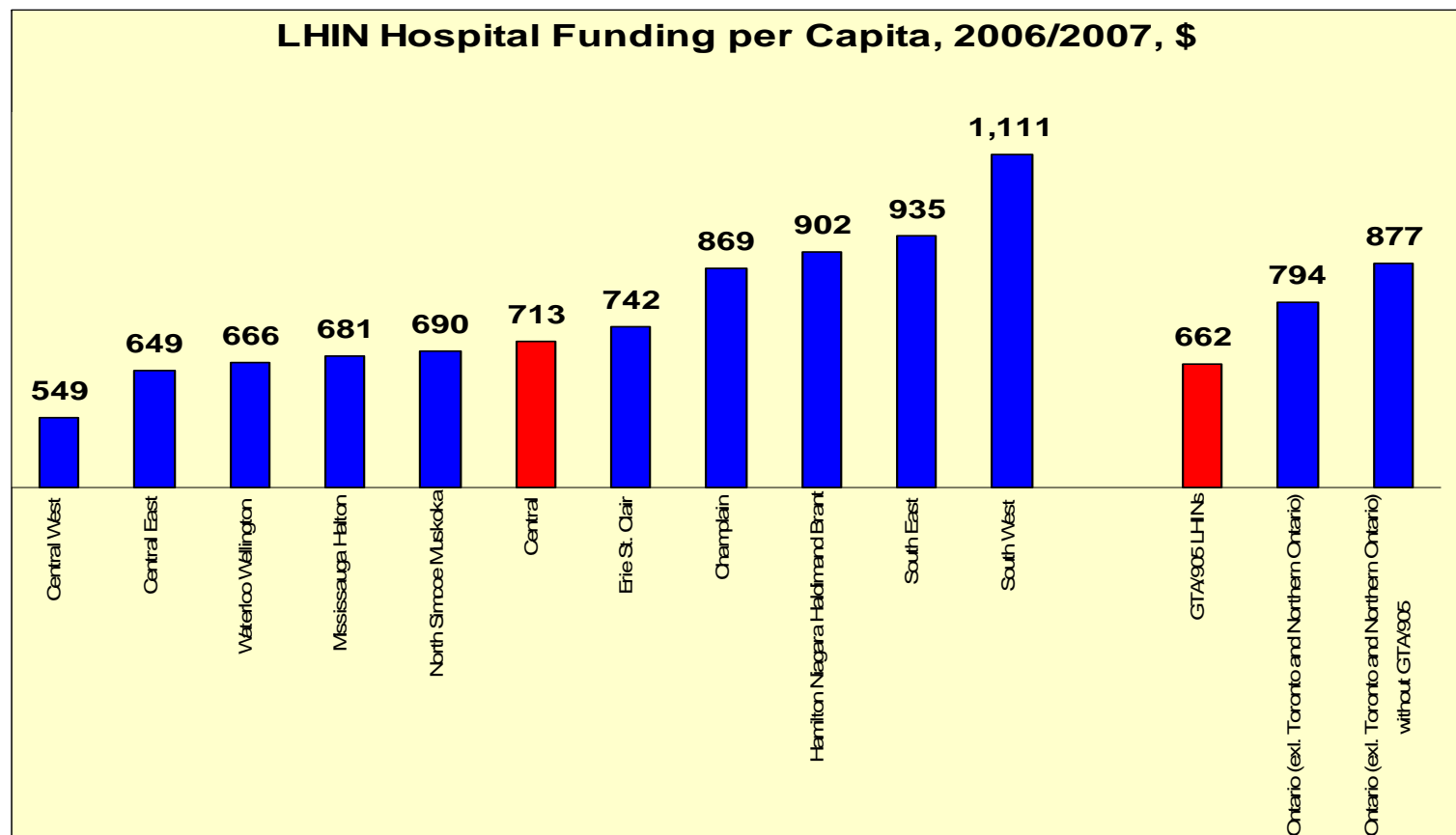

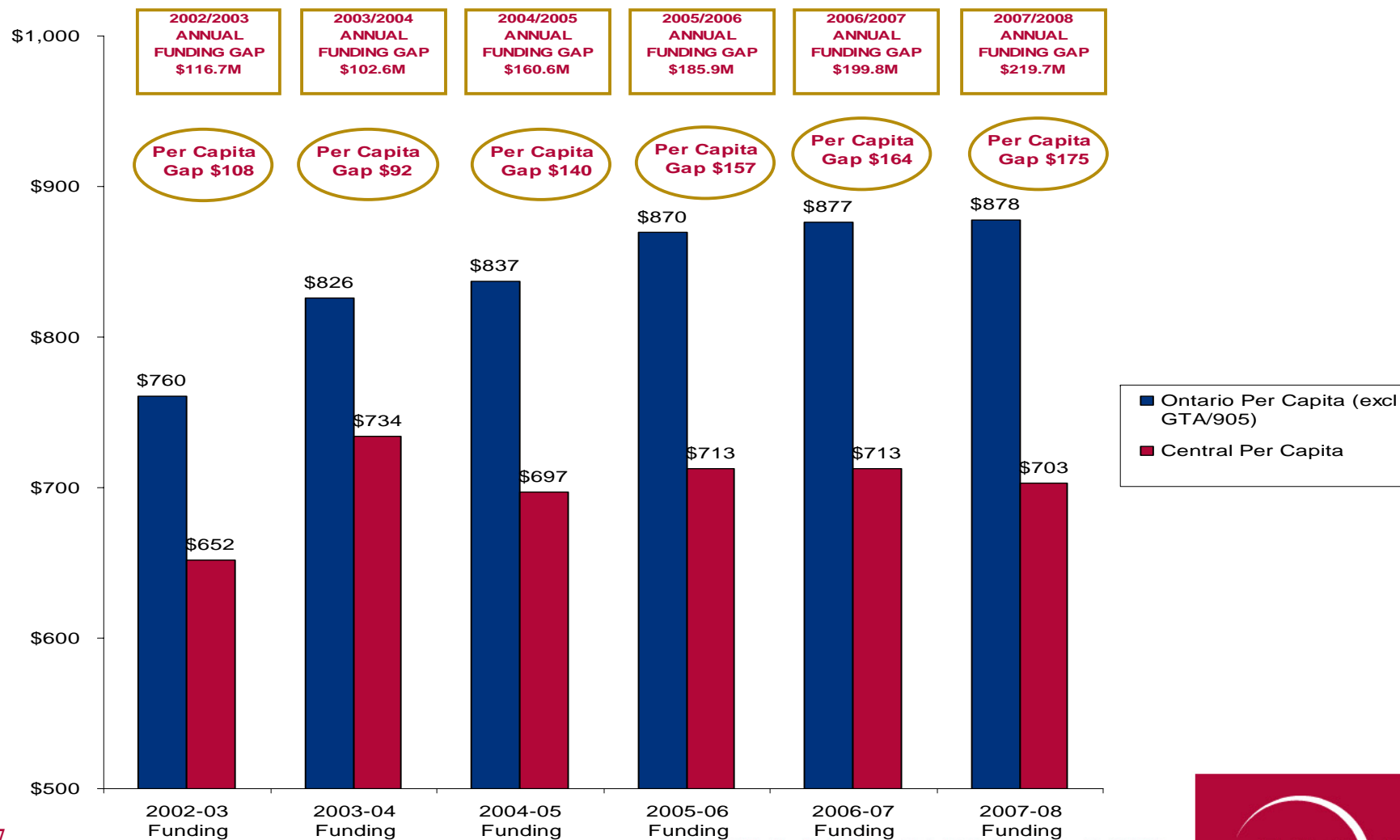
LOCAL HEALTH INTEGRATION NETWORKS (LHINS)

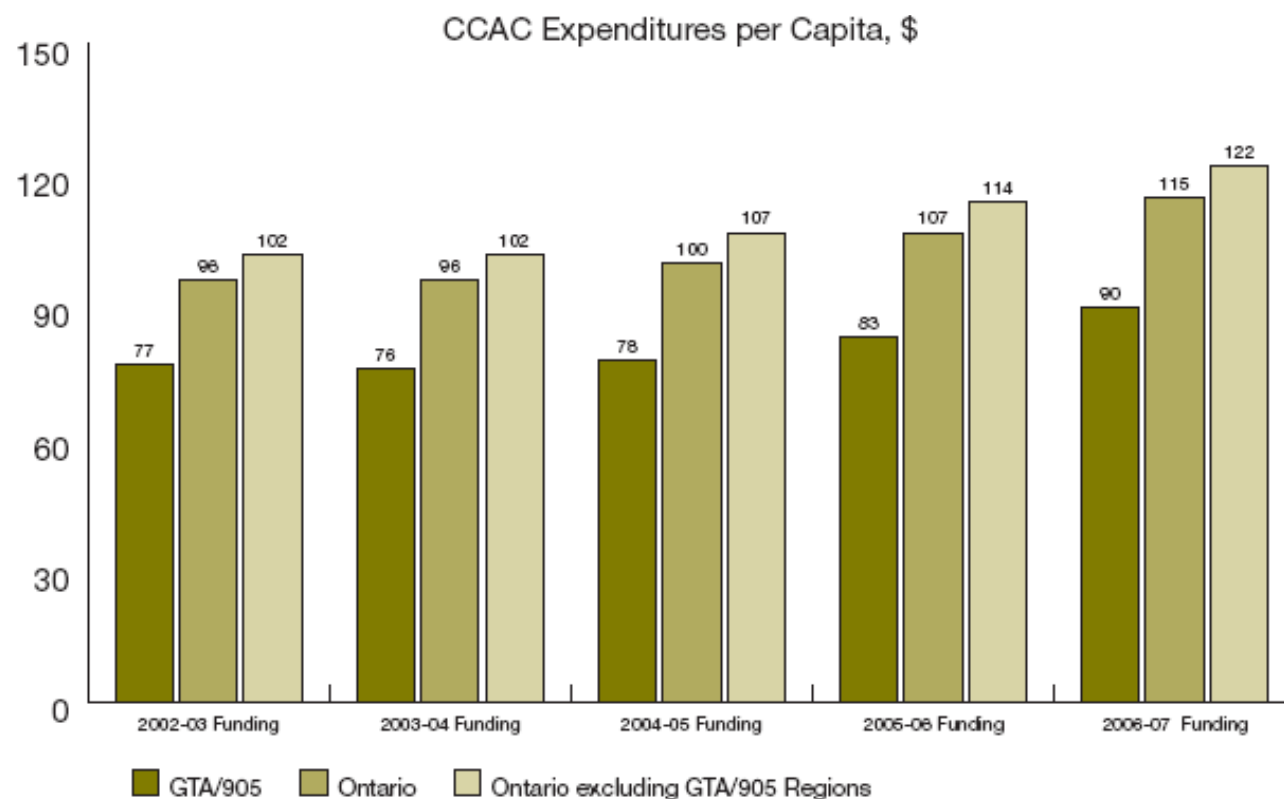

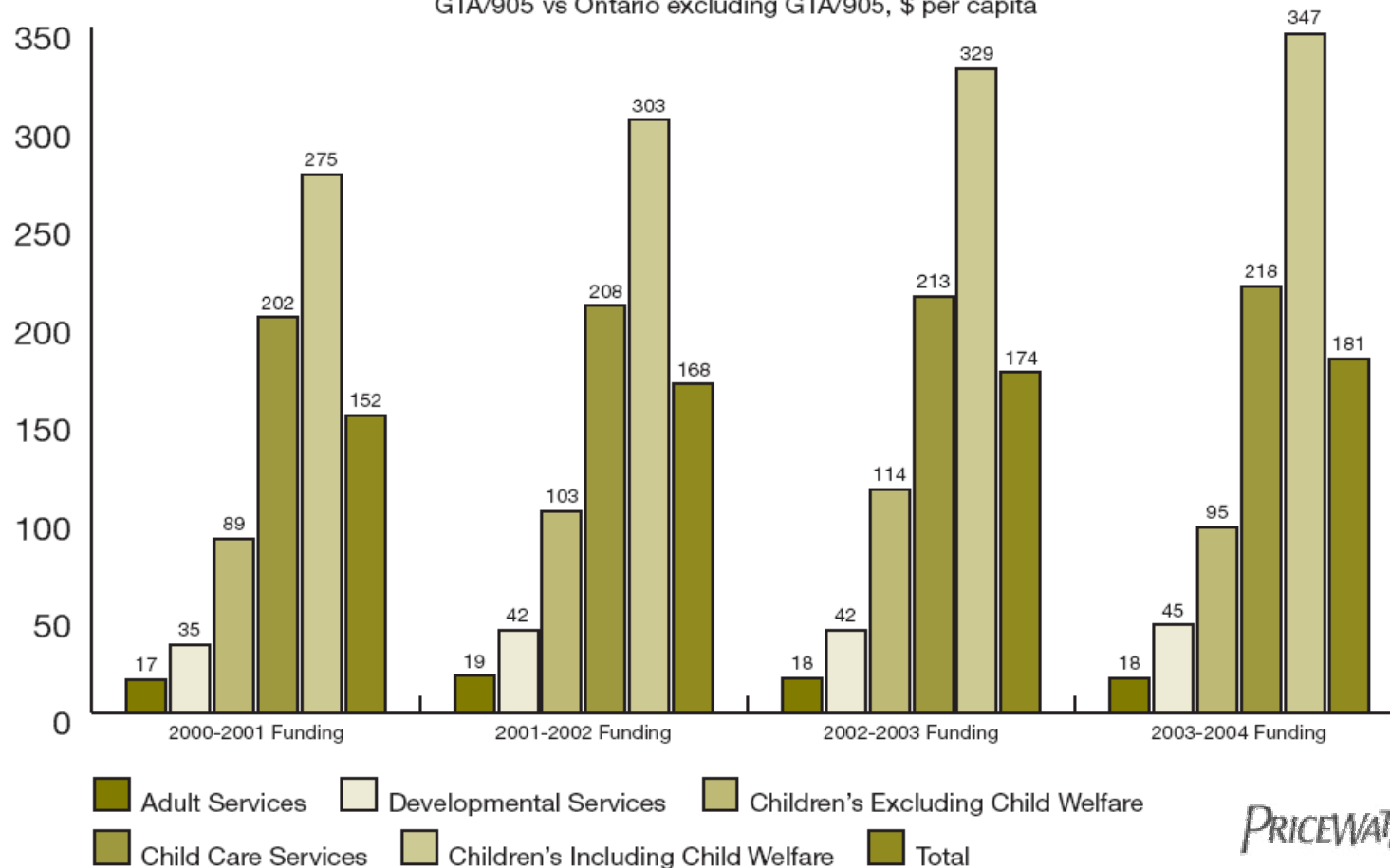

YES. THERE IS A FUNDING GAP

*“Based on the analysis in this document, we conclude **that a sizable gap exists** between per capita health and social services annual operating funding in the GTA/905 area compared to the rest of Ontario, and that the **annual operating funding gap in hospital and Community Care Access Centres (CCAC)** grew over the 2002/03 - 2005/06 period.”*

Paying Our Way

HEALTH TAX CONTRIBUTIONS BY GTA/905 RESIDENTS

- **\$573 million** in new revenue will be collected by the Government from GTA residents through the Health Premium (26% of total premium revenue of \$2.2 billion)
 - **Durham:** **\$109 million** (5% of total premium revenue)
 - **Halton:** **\$96 million** (4%)
 - **Peel:** **\$199 million** (9%)
 - **York:** **\$169 million** (8%)

- 2) Growth Funding
- 3) Politicians “taking note” of GTA/905 Funding Gaps



Better Care Close to Home

WHAT NEEDS TO BE DONE

The Provincial Government should:

1. Provide immediate growth funding to high growth regions for hospitals, health care and social services.
2. Allocate health care funding to LHINs and social services funding to regions based on population size, characteristics and growth, i.e., “population-based funding”
3. Develop a health care and social services strategy for Ontario’s high growth regions to complement *Places to Grow*.

WHAT YOU CAN DO

1. Pass the Resolution before you today and send it to Premier, Minister of Finance and Minister of Health and LTC
2. Write the Premier...ask him to act on three recommendations to build strong GTA/905 communities
3. Let you MPP that there is a fair funding issue in the Markham the GTA/905 that ALSO needs to be fixed.
