#### **PURPOSE:**

The purpose of this report is to obtain approval for the 2015 Budget Committee meeting dates.

### **BACKGROUND:**

The 2015 Budget process includes six Budget Sub-Committee meetings that will be held between January and March 2015. In addition, public input will be sought through a public meeting to be held on March 4th, 2015 at the Civic Centre. It is proposed that the 2015 Budget be approved by Council on March 31, 2015.

Markham is focused on effective fiscal management and operational excellence to ensure sustainability of our City for the future.

In preparing for the 2015 Budget, Staff will continue to look for ways to improve and/or enhance services while seeking opportunities for operational savings through a transparent and consultative budget process.

### 2. Communications Plan

All Budget Sub-Committee meetings are open to the public, and the meetings are audio streamed through Markham's web portal. The presentation discussed during the meeting will be available to view, and a full audio recording of the meeting along with the presentation will be available on the City's website after the meeting.

Notices of the Budget Sub-Committee meetings will be advertised in the Economist & Sun, Thornhill Liberal, Region's radio station 105.9, Markham's electronic information boards, social media, and on Markham's web portal.

A comprehensive communication plan for the 2015 budget process will be developed collaboratively with the Corporate Communications and Community Relations Department, in order to promote active outreach and engagement of residents.

Markham's innovative Citizen Budget Tool is now available on Markham's web portal for the 2015 budget process. It was implemented as part of the 2014 budget process to engage residents and help them better understand how their tax dollars are being used for Markham's programs and services. It also provides residents the opportunity to express their views on how residential tax dollars should be used.

### 3. Councillor Budget Requests

Councillor budget requests should be forwarded to Andrea Tang by Friday, January 9, 2015. The requests will be summarized and distributed to the respective departments for comments which will be addressed at the Budget Sub-Committee meetings. In order to allow sufficient time for Staff to review, evaluate and respond to the requests prior to the start of Budget Sub-Committee meetings in January, submissions received after January 9, 2015 will not be considered.

#### 4. Paperless Capital Budget Initiative

The process of accessing 2015 capital request forms on-line will once again be provided to Members of Council. Training will be provided, if required, prior to the Budget deliberation process. Please contact Andrea Tang if you require training.

Capital Budget binders will only be provided on an exception basis, and requests can be made to Andrea Tang by Friday, January 9, 2015.
