Re: Bob Hunter Memorial Park Planning

On behalf of the Rouge Park Alliance, I wish to thank the Provincial government for setting aside an area in the Rouge River watershed for the new Bob Hunter Memorial Park. This valuable parcel of land protects significant natural heritage of the area and complements Rouge Park's existing protected reservoir of biodiversity.

In order to properly preserve, and provide community opportunities to enjoy the Park, careful planning must take place. Currently, Rouge Park is developing a management plan for the Little Rouge Corridor, which is immediately adjacent to the Bob Hunter Memorial Park.

We are requesting funding to provide park planning for Bob Hunter Memorial Park, as well as the adjacent lands, so that the Memorial Park and Rouge Park can provide a continuous area of natural heritage protection consistent with Ontario's Greenbelt Plan.
