



BY-LAW 2011-31

TO AMEND PARKING BY-LAW 2005-188

BE IT ENACTED BY THE COUNCIL OF THE CORPORATION OF THE TOWN OF MARKHAM THAT Parking By-Law 2005-188 be and the same is hereby amended as follows:

1. That Schedule C of Parking By-Law 2005-188 pertaining to "No Parking" be amended by adding the following:

Rodick Rd.	Both	A point 90m South of Yorktech Dr. and a point 95m North of Fairburn Dr.	Anytime
Yorktech Dr.	Both	Rodick Rd. & Addiscott Court	Anytime
Oakborough Drive	North	Box Grove By-Pass and a point 100m East of Box Grove By-pass	Anytime
Oakborough Drive	South	Box Grove By-Pass and Riverwalk Drive.	Anytime
Ralph Chalmers Avenue	West	Major Mackenzie Drive and a point 65.0m south of Major Mackenzie Drive	Anytime
Ralph Chalmers Avenue	East	Major Mackenzie Drive and Macadam Road	Anytime
Castlemore Avenue	Both	McCowan Road and Stonebridge Drive	Anytime

2. The By-Law shall come into force and effect upon receiving the third reading by the Council of the Town of Markham and also when authorized signs have been erected.
