

BY-LAW 2011-39

A by-law to dedicate certain lands as part of the highways of the Town of Markham

WHEREAS Blocks 32, 34, 36 and 38, Plan 65M-4226, in the Town of Markham, Regional Municipality of York were conveyed to The Corporation of the Town of Markham for public use;

AND WHEREAS Blocks 165 and 172, Plan 65M-3633, in the Town of Markham, Regional Municipality of York were conveyed to The Corporation of the Town of Markham for public use;

AND WHEREAS Blocks 33, 35, 37 and 39, Plan 65M-3634, in the Town of Markham, Regional Municipality of York were conveyed to The Corporation of the Town of Markham for public use;

AND WHEREAS Blocks 25 and 26, Plan 65M-4002, in the Town of Markham, Regional Municipality of York were conveyed to The Corporation of the Town of Markham for public use;

AND WHEREAS Block 127, Plan 65M-3794, in the Town of Markham, Regional Municipality of York was conveyed to The Corporation of the Town of Markham for public use;

AND WHEREAS Block 210, Plan 65M-3519, in the Town of Markham, Regional Municipality of York was conveyed to The Corporation of the Town of Markham for public use;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF MARKHAM HEREBY ENACTS AS FOLLOWS:

- 1. THAT Blocks 32, 34, 36 and 38, Plan 65M-4226, Town of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the Town of Markham and named BUR OAK AVENUE.
- 2. THAT Blocks 165 and 172, Plan 65M-3633, Town of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the Town of Markham and named MINGAY AVENUE.
- 3. THAT Blocks 33, 35, 37 and 39, Plan 65M-3634, Town of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the Town of Markham and named BUR OAK AVENUE.
- 4. THAT Blocks 25 and 26, Plan 65M-4002, Town of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the Town of Markham and named KENTLAND STREET.

- THAT Block 127, Plan 65M-3794, Town of Markham, Regional 5. Municipality of York is hereby established and laid out as part of the public highways of the Town of Markham and named HAMMERSLY BOULEVARD.
- 6. THAT Block 210, Plan 65M-3519, Town of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the Town of Markham and named EVERETT STREET.
