

BY-LAW 2010-94

TO AMEND PARKING BY-LAW 2005-188

BE IT ENACTED BY THE COUNCIL OF THE CORPORATION OF THE TOWN OF MARKHAM THAT Parking By-Law 2005-188 be and the same is hereby amended as follows:

1. That Schedule 1 of Parking By-Law 2005-188 pertaining to "Prohibited Parking" be amended by adding the following:
