

### **Backflow Prevention Program**

- Ministry of Environment (MOE) Drinking Water Inspection Report Recommendation
- Implemented under Safe Drinking Water Act & Ontario Building Code
- Council passed Backflow Prevention Bylaw (No. 2007-142)
  June 2007 & Bylaw Update (No. 2012-27) February 2012
- MOE "A Guide for Drinking Water System Owners Seeking to Undertake a Backflow Prevention Program" posted April 2014, for public consultation.
- The MOE document to be finalized in June 2014

# Markham's Backflow Program

- Extensive program,
  - Applies to all Industrial, Commercial, Institutional (ICI) & multi-residential properties.
  - Applies to existing buildings as well as new constructions
  - Requires assessment by survey as to degree of risk (minor, moderate, or severe)
  - Premise Isolations required for each building with moderate or severe risk.

#### Markham's Program Requirements

- Survey buildings and assess cross connection risks, (resurvey every five years);
- Inspection & Test Backflow Preventers every year to ensure each device is in good working condition;
- Device Upgrade Implementation when Resurvey requires an upgrade of existing device(s) or installation of new device(s);
- Only Qualified Persons registered with the City can do backflow prevention work in Markham

#### **Current Program Survey & Test Status**

- Program rollout over 8 years (Jan 2009 to Dec 2016)
- Currently in 6<sup>th</sup> year of program
- Phase I 7% (66 properties ) not compliant
  - Issuing "order to comply notices" Q2 2014
- Phase II 63% (524) not compliant
  - Final notice requesting compliance are being sent out
  - Issuing of "order to comply notices" will follow Dec 2014- March 2015
- Phase III to start in 2015
- City Facilities will require resurveys in 2015
- City Parks surveys to start in 2014

#### **Program Optimization**

- A customer centric, efficient & effective program requires:
  - multiple information and education tools
  - computerize report submission process such as web portal
  - rigorous review & administration of submissions
  - development of robust data tracking & records management system
  - allow customers secured access to their properties backflow program information 24/7.
  - detail technical policies
  - a site inspection process

### **Customer Service Strategic Priorities**

- Education
  - Comprehensive website in Q3 2012.
  - Backflow Program brochure in Q3 2012.
  - Ten videos on City's website in Q2 2013
- Computerization
  - Portal in Q2 2013 allowing Test Report submission online.
  - Submissions screened accuracy prior to transmittal to City
  - Portal expanded in Q3 2014 allowing all report (Survey, Test, and Device Upgrade) submission online
  - Portal expansion provides property owners access to their buildings backflow prevention records 24/7

## **Program Efficiency**

- Portal
  - Input error check on all Test Report fields & Identifies fields not filled out correctly before accepting transmission
  - This function has significantly helped administrative workload
  - 2014 enhancements to build on current portal success.
- Data tracking & records Management automation
  - Specialized software used & further customized in 2014
  - Can keep all correspondences / records (current & past history)
  - Can review & process the Portal submissions electronically & append records automatically.

## **Program Effectiveness**

- Technical policies
  - A Survey Report is subjective as to the degree of protection & device to be used.
  - Survey Report results in financial impact on property owners so need to make guideline as clear as possible
  - Technical guideline to be completed Q3 2014 intended to standardize practices in Markham and reduce over or under backflow protection
- Site Inspection,
  - Start in late 2014 and include quality control on Survey Reports completed by private contractors.
  - Expect to increase compliance rate through face to face communication & promotion
