



BY-LAW 2010-22

TO AMEND PARKING BY-LAW 2005-188

BE IT ENACTED BY THE COUNCIL OF THE CORPORATION OF THE TOWN OF MARKHAM THAT Parking By-Law 2005-188 be and the same is hereby amended as follows:

1. That Schedule “C” of Parking By-law 2005-188, pertaining to “No Parking”, be amended by deleting the following:

2. That Schedule “C” of Parking By-law 2005-188, pertaining to “No Parking”, be amended by adding the following:

South Town Centre Boulevard	West	Highway #7 and a point 100 metres south thereof	Anytime
South Town Centre Boulevard	West	Clegg Road and a point 45 metres north thereof	Anytime
South Town Centre Boulevard	West	A point 45 metres north of Clegg Road and a point 100 metres south of Highway #7	7:00am to 10:00am; 4:00pm to 6:00pm; Monday to Friday

3. That Schedule “L” of Parking By-law 2005-188, pertaining to “Parking Machine Control Areas”, be amended by adding the following:

South Town Centre Boulevard	West	A point 45 metres north of Clegg Road and a point 100 metres south of Highway #7	10:00am to 4:00pm; 6:00pm to 9:00pm; Monday to Sunday	\$1 per hour; 3-hour maximum period

4. The By-law shall come into force and effect upon receiving the third reading by the Council of the Town of Markham and also when authorized signs have been erected.
