

# **BY-LAW 2009-2**

A by-law to amend By-law No. 2002-276 being a by-law to impose fees or charges for services or activities provided or done by the Town of Markham (Update fees to reflect the change in the Consumer Price Index)

WHEREAS paragraph 391(a) of the Municipal Act, 2001, S.O. 2001, c.25 authorizes municipalities to pass by-laws imposing fees or charges on any class of persons for services or activities provided or done by or on behalf of it; and;

WHEREAS Council at its meeting held on January 20, 2009 approved the increase of user fees and service charges to reflect the change in the Consumer Price Index;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF MARKHAM HEREBY ENACTS AS FOLLOWS:
