

## **BY-LAW 2009-5**

A by-law to dedicate certain lands as part of the highways of the Town of Markham

WHEREAS Blocks 349, 350, 351, 354, 355, 356, 357, 360, 368, 370, 374, 375, 376 and 377, Plan 65M-3888, in the Town of Markham, Regional Municipality of York were conveyed to The Corporation of the Town of Markham for public use;

AND WHEREAS Blocks 175, 178, 181, 182 and 185, Plan 65M-4014, in the Town of Markham, Regional Municipality of York were conveyed to The Corporation of the Town of Markham for public use;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF MARKHAM HEREBY ENACTS AS FOLLOWS:

- 1. THAT Blocks 349 and 357, Plan 65M-3888, Town of Markham, Regional Municipality of York are hereby established and laid out as part of the public highways of the Town of Markham and named WHITE'S HILL AVENUE.
- 2. THAT Block 350, Plan 65M-3888, Town of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the Town of Markham and named LIMESTONE STREET.
- 3. THAT Blocks 351, 354, 355, 356 and 368, Plan 65M-3888, Town of Markham, Regional Municipality of York are hereby established and laid out as part of the public highways of the Town of Markham and named SHADY OAKS AVENUE.
- 4. THAT Blocks 360 and 377, Plan 65M-3888, Town of Markham, Regional Municipality of York are hereby established and laid out as part of the public highways of the Town of Markham and named JOHN ALLAN CAMERON STREET.
- 5. THAT Block 374, Plan 65M-3888, Town of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the Town of Markham and named ROCK GARDEN STREET.
- 6. THAT Blocks 375 and 376, Plan 65M-3888, Town of Markham, Regional Municipality of York are hereby established and laid out as part of the public highways of the Town of Markham and named LANE "H".
- 7. THAT Block 370, Plan 65M-3888, Town of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the Town of Markham and named LANE "F".
- 8. THAT Block 175, Plan 65M-4014, Town of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the Town of Markham and named LANE "W".
- 9. THAT Block 178, Plan 65M-4014, Town of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the Town of Markham and named CORNELL ROUGE BOULEVARD.

- 10. THAT Block 181, Plan 65M-4014, Town of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the Town of Markham and named JOHN ALLAN CAMERON STREET.
- 11. THAT Block 182, Plan 65M-4014, Town of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the Town of Markham and named LANE "V".
- 12. THAT Block 185, Plan 65M-4014, Town of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the Town of Markham and named ALBERT LEWIS STREET.
