

BY-LAW 2008-241

TO AMEND SPEED BY-LAW 105-71

BE IT ENACTED BY THE COUNCIL OF THE CORPORATION OF THE TOWN OF MARKHAM THAT BY-LAW NUMBER 105-71 BE AND THE SAME IS HEREBY AMENDED AS FOLLOWS:
