

EXPLANATORY NOTE

BY-LAW NO. 2008-250

A By-law to amend By-law 304-87, as amended.

On the north side of 14th Avenue, east of 9th Line.
Lots 4 and 5 on Block E of Registered Plan 19 and Part Lot 6, Concession 9
Box Grove Planning District

LANDS AFFECTED

This proposed By-law Amendment applies to a 3.25 hectare (8.1 acres) portion of the 3.6 hectare (8.8 acres) parcel of land legally described as Lots 4 and 5 on Block E of Registered Plan 19 and Part Lot 6, Concession 9, located on the north side of 14th Avenue, east of 9th Line within the Box Grove community.

EXISTING ZONING

The northerly portion of the subject lands are zoned Rural Residential Four (RR4) in By-law 304-87, as amended. A portion of the subject lands are to be deleted from the designated areas of By-law 304-87, as amended.

PURPOSE AND EFFECT OF THIS BY-LAW

The purpose and effect of this By-law Amendment is to delete a portion of the subject lands from the designated area of By-law 304-87, as amended, and to incorporate the lands within the designated area of By-law 177-96, as amended.

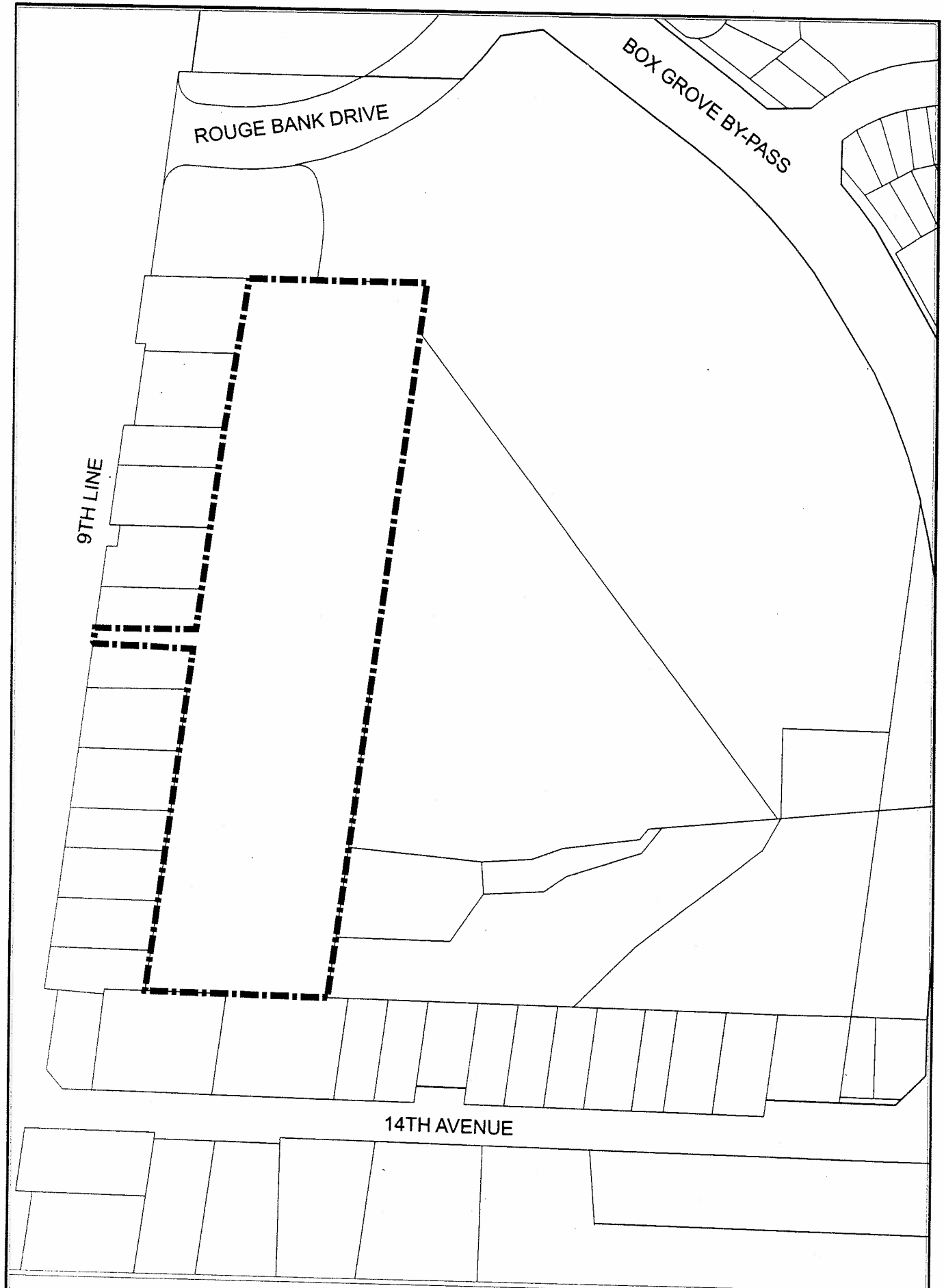
THE COUNCIL OF THE CORPORATION OF THE TOWN OF MARKHAM
HEREBY ENACTS AS FOLLOWS:

1. By-law 304-87, as amended, is hereby further amended by deleting a portion of those lands comprised of Lots 4 and 5 on Block E of Registered Plan 19 and Part Lot 6, Concession 9, as shown on Schedule 'A' attached hereto, from the designated area of By-law 304-87, as amended.
2. This By-law shall not come into effect until By-law 2008-252, amending By-law 177-96, as amended, comes into effect and the lands, as shown on Schedule 'A' attached hereto, are incorporated into the designated area of By-law 177-96, as amended.
3. All other provisions of By-law 304-87, as amended, not inconsistent with the provisions of this by-law shall continue to apply

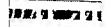
