

## **BY-LAW 2007-285**

A by-law to dedicate certain lands as part of the highways of the Town of Markham

WHEREAS Blocks 78 to 85 inclusive and Blocks 93 to 100 inclusive, Plan 65M-3837, in the Town of Markham, Regional Municipality of York were conveyed to The Corporation of the Town of Markham for public use;

AND WHEREAS Blocks 382, 383 and 384, Plan 65M-3838, in the Town of Markham, Regional Municipality of York were conveyed to The Corporation of the Town of Markham for public use;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF MARKHAM HEREBY ENACTS AS FOLLOWS:

- 1. THAT Blocks 78 and 93, Plan 65M-3837 and Block 384, Plan 65M-3838, Town of Markham, Regional Municipality of York are hereby established and laid out as part of the public highways of the Town of Markham and named RIZAL AVENUE.
- 2. THAT Blocks 79 and 80, Plan 65M-3837, Town of Markham, Regional Municipality of York are hereby established and laid out as part of the public highways of the Town of Markham and named CONDARCURI CRESCENT.
- 3. THAT Blocks 81 and 83, Plan 65M-3837, Town of Markham, Regional Municipality of York are hereby established and laid out as part of the public highways of the Town of Markham and named ALBERT ROFFEY CRESCENT.
- 4. THAT Blocks 82 and 100, Plan 65M-3837, Town of Markham, Regional Municipality of York are hereby established and laid out as part of the public highways of the Town of Markham and named RIVERWALK DRIVE.
- 5. THAT Blocks 84, 95 and 96, Plan 65M-3837, Town of Markham, Regional Municipality of York are hereby established and laid out as part of the public highways of the Town of Markham and named OAKBOROUGH DRIVE.
- 6. THAT Blocks 85 and 97, Plan 65M-3837, Town of Markham, Regional Municipality of York are hereby established and laid out as part of the public highways of the Town of Markham and named GALTEN ROAD.
- 8. THAT Blocks 94, 98 and 99, Plan 65M-3837, Town of Markham, Regional Municipality of York are hereby established and laid out as part of the public highways of the Town of Markham and named STONECHURCH CRESCENT.
- 8. THAT Block 382, Plan 65M-3838, Town of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the Town of Markham and named SMOOTHWATER TERRACE.

9. THAT Block 383, Plan 65M-3838, Town of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the Town of Markham and named HISLOP DRIVE.
