As promised I am enclosing confirmation of residents application requesting water services. Of the 25 homes on your petition, 23 requests water services.

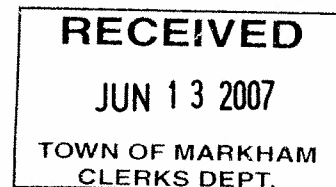
Over the last few years there has been a decline in our well water supply, to the point of great concern. If this trend continues, our community could run out of ground water in the near future.

## PETITION FOR A LOCAL IMPROVEMENT FEASIBILITY STUDY

**To: The Council of the Corporation of the Town of Markham**

**From: Property Owners on Carolwood Crescent and Palatin Court**

**Re: Provision of Municipal Water Service**

The undersigned, being the owners of property on Carolwood Crescent or Palatin Court, request the Town of Markham to conduct a feasibility study with respect to the provision of municipal water service to our properties.

We understand that:

- the feasibility study would provide an estimate of the cost to design and construct a watermain on the street, which would include a water service connection from the watermain to the property line for each dwelling;
- the above cost estimate would be presented by Town staff to the property owners and then the property owners would be requested to submit another petition to the Town to indicate their desire to proceed with construction of the above water distribution system; and,
- the property owners would be required to pay for the full cost of the water distribution system, including the cost of the feasibility study, should the system be constructed.

We further understand that:

- water service connections from the property line to each dwelling would not be included as part of the Town's project, and the Town would not be providing any cost estimate to the property owners for such connections; and,
- each property owner would be required to arrange and pay for the construction of a water service connection from the property line to their dwelling, should the water distribution system be constructed.
