# TO BY-LAW 2007-20

A by-law to amend By-law 2571, as amended.

## ROYAL DAVID REALTY INC. 2300 John St. Part of lot 4, Concession 3

#### LANDS AFFECTED

The proposed by-law amendment applies to an approximately 1.13 ha (2.79 ac) property, located at the northeast corner of Leslie and John Streets. The property contains a single-storey multi-tenant local commercial plaza.

#### **EXISTING ZONING**

The lands subject to this by-law are presently zoned Local Community Commercial (LCC) by By-law 2571, as amended.

### PURPOSE AND EFFECT

The purpose and effect of this by-law amendment is to amend the Zoning By-law to provide for a more general range of retail and personal service uses, as well as permit commercial schools, medical offices, take-out restaurants and one veterinary clinic (which may also include ancillary boarding of pets) within the existing multi-tenant local commercial plaza.



# **BY-LAW 2007-20**

A by-law to amend Zoning By-law 2571, as amended

THE COUNCIL OF THE CORPORATION OF THE TOWN OF MARKHAM HEREBY ENACTS AS FOLLOWS:

- 1. That By-law 2571, as amended by By-law 256-81, be amended as follows:
  - 1.1 By deleting the definitions for "CONVENIENCE FOOD STORE" and "VARIETY STORE" from Subsection 4 (a).
  - 1.2 By deleting Subsection 4 (c) in its entirety and replacing it with a new Subsection 4 (c) as follows:

#### "(c) PERMITTED USES

The lands shown on Schedule 'A' attached hereto shall not be used for any purpose other than a SHOPPING CENTRE, containing any of the following:

- banks and financial institutions
- business and professional offices
- commercial schools
- medical offices
- personal service shops
- commercial fitness centres
- RESTAURANTS
- FAST FOOD RESTAURANTS
- TAKE OUT RESTAURANTS
- retail stores
- one veterinary clinic, which may also include ancillary boarding of pets"
- 1.3 By deleting Subsection 4 (d) in its entirety and replacing it with a new Subsection 4 (d) as follows:

## "(d) PROHIBITED USES

- amusement centres
- bowling alley
- billiard halls
- automobile and motorcycle sales and/or repair
- boat and snowmobile sales and/or repair
- day care centres
- cinema"
- 1.4 By deleting Subsection 4 (e) (vii) in its entirety and renumbering all other provisions accordingly.

2. All other provisions of By-law 2571, as amended, not inconsistent with the provisions of this by-law shall continue to apply.
