NOTICE OF PUBLIC CONSULTATION CENTRE #2

The Regional Municipality of York is undertaking a Class Environmental Assessment (Class EA) study to address existing and future road needs and improvements on Bayview Avenue (Y.R. 34), from John Street to Major Mackenzie Drive (Y.R. 25) within the Towns of Markham and Richmond Hill. The study is being conducted in accordance with Schedule 'C' of the *Municipal Class Environmental Assessment* (June 2000) process, which is an approved process under the *Ontario Environmental Assessment Act*. The study area is shown below.

The first Public Consultation Centre was held on April 4, 2006 to present the collection of background information, the problem being addressed and the alternatives being considered to address existing and future needs for Bayview Avenue. In light of comments received during and after this first meeting, the needs and justification for road improvements on Bayview Avenue were further reviewed and opportunities to address these needs were further identified.

A second Public Consultation Centre has been arranged to obtain additional public input on the need for improvements to Bayview Avenue. Details of the Public Consultation Centre are noted below. Following the consultation centre, public comments will be reviewed and alternatives for the recommended improvement will be developed in more detail, analyzed and evaluated in comparison with each other. At that time, a third Public Consultation Centre will be arranged for review and comment by the public.



In late 2005, The Regional Municipality of York commenced a study of Bayview Avenue from John Street to Major Mackenzie Drive East in accordance with the *Municipal Class Environmental Assessment* (June 2000) process as approved under the Ontario Environmental Assessment Act. On behalf of the Regional Municipality of York, we are writing to advise you of the second Public Consultation Centre (PCC) for the above study.
