\* The Town of Markham wants us to replace the car every seven years, (which was opposed by Markham Taxi owners/operators), why should there be a fee to register the same!

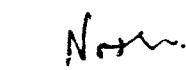

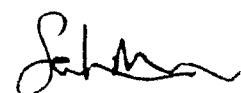

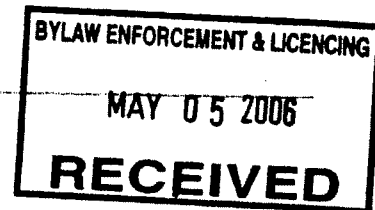
