RECOMMENDATION:

THAT the report entitled "Award of Tender 091-T-06, Construction of Highglen Neighbourhood Park" be received;

AND THAT the contract for tender 091-T-06 for the construction of Highglen Neighbourhood Park be awarded to the lowest priced bidder, Mopal Construction in the amount of \$459,810.00, exclusive of a \$45,000.00 contingency and GST;

AND THAT a consultant and construction contingency amount of \$45,000.00 exclusive of GST, be established to cover additional consultant/construction costs and that the Director of Planning & Urban Design or designate be authorized to approve expenditures of this contingency amount up to the specified amount in accordance with the Expenditure Control Policy;

AND THAT the award be funded from Planning and Urban Design's 2005 Capital Budget account 81-5350-6651-005, Highglen Neighbourhood Park, in the amount of \$599,500.00;

AND FURTHER THAT upon payment of all invoices associated with this project, any remaining funds will be returned to the original funding sources;

PURPOSE:

The purpose of this report is to award the contract for the construction of Highglen Neighbourhood Park located north of Ellen Fairclough Public School, south of Highglen Avenue, east of Brando Avenue and west of Markham Road in Milliken Mills.

BACKGROUND:

Marshall Macklin Monaghan was hired as the consulting landscape architects to provide design and contract administration services and to administer any sub-consultants as required.

A contingency of \$45,000.00 has been established to cover any additional and unanticipated design and/or construction costs including authorized contingencies and approved change orders associated with this project.

Upon payment of all invoices associated with this project, any remaining funds will be returned to the original funding sources.

OPTIONS/ DISCUSSION:

The construction tender 091-T-06 was issued in accordance with the Purchasing By-law 2004-341. Staff and the consultant have reviewed the bid documents and are satisfied that all terms, conditions, bid prices and specifications comply with the Town's requirements.
