I am writing on behalf of the residents of Monkhouse Road in the Wynberry Developments subdivision. We have recently become aware that some of the Town Councillors would like a change in the type of homes that are to be built on the south side of Monkhouse Road, and we wish to voice our disappointment in this news.

When we purchased our homes a few years ago, the plan was that Ballantry Homes was to build large, estate type, luxury homes on the 60 foot lots on the south side of Monkhouse Road. For most of us, this information played a very large part in our lot selection process, as obviously these upscale homes on our street would ultimately increase the value of our homes.

To our dismay, we recently found out that the residents of Heritage Estates have objected to these plans and have tried to convince some of the Councillors and yourself at the Town of Markham that the homes should be bungalows and short two storey homes. This is very upsetting to us all especially when we were not advised of this change and have not been given the opportunity to have our say. This is **our** street – not theirs! Why should they be able to decide what is to be built on our street? We are the ones who are affected by this enormous change and we feel that the Town of Markham is trying to "sneak" this by us. It's **our** property values that will decrease.

We are asking that the Councillors please reconsider this grossly unfair decision and understand our position. The purchase of our homes has been the largest investment we have ever made. We've anticipated the construction of the estate type homes to complete our street and eventually increase our property values. For this to be compromised by people who do not even live on our street is extremely unfair. Mr. McKelvey's job is to look out for the well-being of all his constituents, not for one very small group of people from another subdivision that really has no business in making decisions on what happens on our street.

As you can see by the attached petition, all residents (except one who is out of town) on Monkhouse Road, directly across from the 60 foot lots from Spencer Avenue to the end, oppose the new plan for bungalows and short two storey homes.
