Sewer Relocation  
By-law 218-86 Exemption  
February 14, 2006

WHEREAS the Region of York is currently replacing a Regional sewer under the Milne Pond;

AND WHEREAS the Ministry of National Resources requires such work be completed by March 31, 2006;

AND WHEREAS the Region of York has requested approval to work if necessary Sunday's from 0800 to 1700 to meet the project deadline.

And that an exemption to the Town of Markham's Noise By-law #218-86 be approved to permit the Region of York and its contractor to work 0800 to 1700 hours Sunday from February 19, 2006 to March 26, 2006 for sewer construction;

And that the above exemption be subject to the Region and its consultant advising abutting residents on Riverview Avenue and Willowgate Drive.

Further to your request we confirm that we are the Project Managers for the Region for the above captioned project.

This project is currently underway to eliminate an existing hazardous situation by replacing a portion of the Markham Collector sewer currently within the pond area and which can no longer be maintained. We have attached a map of the work area for your reference.

MacViro Consultants Inc. is the Consulting Engineer overseeing the Construction and Contract Administration on site. Technicore Underground Inc. is the Contractor who is completing the work.

The MNR will not allow in-water works between March 31 and July 1. Technicore has requested that the Bylaw be amended to allow works to continue on Sundays from 8:00a.m. to 5:00 p.m. for emergency works should it be necessary to meet the March 31 deadline and thereby minimize disruption to the Park during the summer period. There would be no trucks or machinery arriving or leaving the site on Sunday.

Technicore has been pro-active in dealing with local residents and there are no outstanding issues at this time.
