### **A by-law to amend By-law No. 2012-137, being a by-law to impose fees or charges for licences and permits issued by the City of Markham**

WHEREAS paragraph 391(a) of the Municipal Act, 2001, S.O. 2001, c.25 authorizes municipalities to pass by-laws imposing fees or charges on any class of persons for services or activities provided or done by or on behalf of it;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF MARKHAM HEREBY ENACTS AS FOLLOWS:

1. That the Schedules “A”, “B” and “C” of By-law No. 2012-137, being a by-law to impose fees or charges for licences and permits issued by the City of Markham, be deleted and the attached Schedules of this by-law be included.
2. That this by-law comes into force and takes effect upon its passage.
3. All other provisions of By-law 2012-137, except as herein amended or effected, which are not inconsistent with the provisions of this By-law, shall continue to apply.
